

FACTORY AND WORKSHOP ACT, 1901.

In pursuance of section 1 of the Rules Publication Act, 1893, notice is hereby given that the Secretary of State for the Home Department proposes, at the expiration of 40 days from the publication of this notice, to make an Order under sections 107, 108, and 110 of the Factory and Workshop Act, 1901, applying the provisions of section 107 (relating to lists of outworkers), section 108 (relating to employment in unwholesome premises), and section 110 (relating to the prohibition of home-work in places where there is infectious disease) to the following classes of work in addition to those specified in the Home Work Orders of 11th December, 1901, and 14th July, 1902, viz. :—

The making of covers for, and the covering, finishing, altering or repairing of, umbrellas, sunshades, parasols, and articles of a similar character, and any work incidental thereto ;

The making of paper bags and of paper boxes ;
Brushmaking ; and

The making of stuffed dolls.
