LONDON COUNTY COUNCIL (TRAMWAYS) BILL.

(Alteration of Works.)

NOTICE is hereby given, that during the progress of the above Bill through the House of Commons (in which Honourable House the Bill originated), provision has been made for certain alterations of the line or situation of Tramways Nos. 1, 1A, and 2, as originally proposed to be authorised by the Bill as introduced into Parliament.
