
ORDER OF THE BOARD OF AGRICULTURE AND FISHERIES.

(DATED 8TH AUGUST 1905.)

The Board of Agriculture and Fisheries, by virtue and in exercise of the powers vested in them under the Diseases of Animals Acts, 1894 to 1903. and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

The dates between which all sheep in the Compulsory Dipping Area described in the Schedule to this Order are to be treated by the owner for sheep-scab by effective dipping under Article 2 of the Sheep-Scab (Compulsory Dipping Areas) Order of 1905 are hereby fixed to be the first day of September and the twenty-ninth day of the same month in every year.

SCHEDULE.

L.S.

An Area comprising those parts of the administrative counties of Durham and Cumberland which lie within the following boundary (excluding the roads which form part of that boundary), namely:—

Commencing at a point where the Darlington and Tebay Branch of the North Eastern Railway crosses the River Tees, on the boundary between the counties of Durham and York, north-west of Barnard Castle, and thence proceeding in a northwesterly direction along that boundary to the point of junction of the counties of Cumberland, Durham, and Westmorland, at Crookburn Beck, thence northerly along the boundary between the counties of Cumberland and Durham, to the point where Crookburn Beck is crossed by the main road from Alston to Middleton in Teesdale, thence northwesterly following the course of that road to the point of its junction with the main road from Garrigill to Nenthead, thence north-easterly along that road through Nenthead to the boundary between the counties of Cumberland and Northumberland at Black Hill, thence south-easterly along that boundary and easterly and northeasterly along the boundary between the counties of Durham and Northumberland to Allensford Bridge, thence southerly along the main road through Castleside to Bridge-street, Towlaw, thence easterly along that street to the Police Station, thence southerly along the main road by West Park and Helme Park to the guide post opposite to the eastern corner of Collier Wood, thence southerly along the road to the southern corner of Cold Knot West plantation, thence south-westerly along the road to the guidepost at the junction of the four roads near the fourth milestone from Wolsingham, thence southeasterly along the road by Harperley Lodge to Fir Tree Inn, thence southerly along the main road to Witton-le-Wear Green, thence southerly and easterly along the main road through Toft Hill to High Etherley, thence south-easterly along the main road leading to West Auckland to the point where that road is crossed by the Barnard Castle Branch of the North Eastern Railway,

thence south-westerly along that railway to the point of commencement.

POST OFFICE. POSTAL ORDERS

In pursuance of the Rules Publication Act, 1893, His Majesty's Postmaster-General hereby gives notice that Regulations, dated the 31st day of July, 1905, have been made by him (with the consent of the Treasury) in pursuance of the Post Office (Money Orders) Acts, 1848 to 1904, in relation to the exchange of postal orders between the United Kingdom, on the one hand, and Natal, the Orange River Colony, and the Transvaal Colony, on the other hand.

REGISTRATION OF BIRTHS AND DEATHS.

Notice is hereby given, that in pursuance of the provisions of the twenty-first section of an Act passed in the thirty-eighth year of the reign of Her late Majesty, intituled "The Births and Deaths Registration Act, 1874," I, Sir William Cospatrick Dunbar, Bart., C.B., Registrar-General of Births, Deaths, and Marriages in England, have, with the sanction of the Local Government Board, ordered and declared that, on and after the first day of September next, in order that the number of Sub-Districts into which Thirsk Registration District is at present divided may be reduced, Knayton Sub-District of that Registration District shall be abolished and its constituent Civil Parishes dealt with in the following; manner viz.:—(a) Boltby, Kepwick, Cowesby, and Kirkby Knowle Civil Parishes shall be transferred to Sutton Sub-District of Thirsk Registration District, and (b) Upsall, Knayton-with-Brawith, North Kilvington, Thornbrough, Thornton-le-Street, Thornton-le-Moor, and South Otterington Civil Parishes shall be transferred to Thirsk Sub-District of Thirsk Registration District.—Witness my hand this 4th day of August, one thousand nine hundred and five.

KENT WATERWORKS COMPANY.

In the Matter of the Metropolis Water Act, 1902, and in the Matter of the Kent Waterworks Company, in Liquidation.
