SCHEDULE.

An Area comprising that part of the administrative county of Carnarvon which lies within the following boundary, but excluding the roads which lie along that boundary, namely:—

Commencing at the suspension bridge over the river Conway at Conway Castle, and proceeding thence southerly along the western bank of that river to the point where Afon Crafnant falls into the river, thence following the course of that stream to where it passes under the bridge at Trefriw, thence south-easterly along the main road by Gwydyr Gate to the $\frac{1}{2}$ mile stone from Llanrwst, thence north-easterly along the main road to Pont Fawr, thence southerly following the western bank of the river Conway to Waterloo Bridge, thence north-westerly and westerly along the main road through Bettws-y-Coed, by Pont-Ty-lyll to Capel Curig, thence south-westerly along the main road to Pen-y-Gwrhyd Hotel, thence southerly and westerly along the main road by the south-eastern side of Llyn Gwynant and the north-western side of Llyn Dinas to the bridge over Afon Colwyn at Beddgelert, thence westerly and southerly along the main road by Dinas-ddû to Turnpike-y-traeth, thence south-westerly along the main road by Pren-têg to Portreuddyn Castle, thence westerly by the main road through Tremadoc to Penmorfa, thence north-westerly along the main road to Dolbenmaen, thence westerly along the main road to the smithy at Glan-Dwyfach corner, thence northerly along the main road through Brynkir, Llanlyfni, and Pen-y-groes to the junction of the four cross roads at Groeslon Railway Station, thence westerly along the main road by Ffrwd, through Llandwrog to its junction with the road from Bodfan to Carnarvon Bay Hotel, thence north-westerly along that road to its termination at the coast line, thence northerly and easterly along the coast line to the point of commencement.

INSTRUMENT substituting the New Church called Christ Church, situate within the parish of Hanham, in the county of Gloucester, and in the diocese of Bristol, for the Old Church of Saint George, situate within and hitherto being the Parish Church of the same parish.

To all to whom these presents shall come the Ecclesiastical Commissioners for England send greeting.

WHEREAS a new church has been built within the parish of Hanham, in the county of Gloucester, and in the diocese of Bristol, and has been consecrated and dedicated by the name of Christ Church.

And whereas the Right Reverend George Forrest, Bishop of the said diocese of Bristol, as Diocesan, the Reverend Henry Nicholson Ellacombe, Clerk in Holy Orders, Honorary Canon of Bristol and Vicar of Bitton, in the said

county and diocese, as the patron of the vicarage of the said parish of Hanham, and the Reverend Charles William Bate, Clerk in Holy Orders, as the Vicar or Incumbent of the said vicarage of Hanham, have by an Instrument under their hands, bearing date on or about the first day of June, in the year one thousand nine hundred and five, certified to us, the said Ecclesiastical Commissioners for England, that it would be for the convenience of the said parish of Hanham that the said new church called Christ Church, situate within such parish, should be substituted for the old parish church (dedicated to Saint George) of the same parish.

Now, therefore, we the said Ecclesiastical Commissioners for England, in exercise and execution of the power or authority in that behalf contained in the Act of the eighth and ninth years of Her late Majesty Queen Victoria, chapter seventy, and in the Act of the nineteenth and twentieth years of Her said late Majesty, chapter fifty-five, and of all other powers or authorities in anywise enabling us in the same behalf, do by this Instrument, under our common seal, with the consents (testified as hereinafter mentioned) of the said George Forrest, Bishop of the said diocese of Bristol, and of the said Henry Nicholson Ellacombe and Charles William Bate, hereby declare that the said new church called Christ Church, situate within the said parish of Hanham, and duly consecrated as aforesaid, shall be and the same is hereby substituted for the said old parish church (dedicated to Saint George as aforesaid) of the same parish, and that such new church shall henceforth be the parish church of the said parish of Hanham, in lieu of the said old parish church of Saint George, as fully in all respects as if the said new church called Christ Church, so hereby substituted, had been originally the parish church of the same parish; and we, the said Ecclesiastical Commissioners for England, in further pursuance and exercise of the powers and authorities aforesaid, and with such consents as aforesaid (testified as hereinafter mentioned), do hereby transfer all the endowments, emoluments, and rights of or belonging to the said old parish church (dedicated to Saint George as aforesaid) of the said parish of Hanham, or of or belonging to the Vicar or Incumbent thereof, to the said new church called Christ Church, now being by virtue of these presents the parish church of the said parish of Hanham, and to the Vicar or Incumbent thereof, and his successors, for ever.

In witness whereof to these presents we, the said Ecclesiastical Commissioners for England, have set our common seal, and the said George Forrest, Bishop of the said diocese of Bristol, has set his hand and affixed his episcopal seal, and the said Henry Nicholson Ellacombe and Charles William Bate have respectively set their hands and affixed their seals this twenty-ninth day of June, in the year one thousand nine hundred and five.
