# ORDER OF THE BOARD OF AGRICULTURE AND FISHERIES.

(DATED 25TH AUGUST 1905.)

The Board of Agriculture and Fisheries, by virtue and in exercise of the powers vested in them under the Diseases of Animals Acts, 1894 to 1903, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

Notwithstanding the provisions of the Swine-Fever (Regulation of Movement) Order of 1903, or of any Order by which such provisions are applied to any scheduled area, swine may be moved from the exhibition mentioned in the Schedule hereto to any place of destination in Great Britain situate in any scheduled area, if accompanied by a Licence authorising such movement granted by an Inspector of the Local Authority of the District in which is situate the place to which the swine are proposed to be moved.

The swine shall be moved by the nearest available route and without unnecessary delay to the place of destination specified in the licence and not elsewhere, and while being so moved shall not be subject to Regulations made by
