The operation of the provisions of Part II (Regulation of Exposure and Movement of Sheep in Compulsory Dipping Areas) of the Sheep-Scab (Compulsory Dipping Areas) Order of 1905 shall be suspended in their application to the Compulsory Dipping Area described in the Schedule to this Order from and after the sixth day of September, nineteen hundred and five, until the fifteenth day of April, nineteen hundred and six.

Rams entered for sale at either of the Sales specified in the Schedule to this Order shall be exempt from the provisions of the Sheep-Dipping (Scotland) Order of 1905, but such rams shall not be moved out of the Dipping Area to which such Order relates, unless accompanied by a Licence granted by an Inspector of the Local Authority of the district from which they are so moved, which Licence shall only be granted upon production of a veterinary certificate showing freedom from disease or a declaration signed by the owner of the sheep or his agent authorised in writing for this purpose to the effect that the rams have been dipped since the eighteenth day of June, nineteen hundred and five.
