

ORDER OF THE BOARD OF
AGRICULTURE AND FISHERIES.

(DATED 4TH SEPTEMBER 1905.)

The Board of Agriculture and Fisheries, by virtue and in exercise of the powers vested in them under the Diseases of Animals Acts, 1894 to 1903, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows :

The operation of the provisions of Part II (*Regulation of Exposure and Movement of Sheep in Compulsory Dipping Areas*) of the Sheep-Scab (*Compulsory Dipping Areas*) Order of 1905 shall be suspended in their application to the Compulsory Dipping Area described in the schedule to this Order from and after the seventh day of September, nineteen hundred and five, until the fifteenth day of April, nineteen hundred and six.

In witness whereof the Board of Agriculture and Fisheries have hereunto set their Official Seal this fourth day of September, nineteen hundred and five.

SCHEDULE.

An Area comprising those parts of the West Riding of the county of York, of the county of Lancaster, and of the borough of Todmorden, which lie within the following boundary, but excluding the boroughs of Burnley, Colne, and Nelson, and also the roads which lie along the line of boundary, namely :—

Commencing at a point where the main road from Colne to Haworth crosses the county boundary, thence to Haworth Railway Station, thence following the Midland Railway line to Oxenhope Railway Station, thence following the main road through Leeming, Denholme, Denholme Gate, and Causeway Foot to Park-lane End, thence in a south-westerly direction and following the road through Upper Brockholes to where the said road joins the road leading to Mixenden, thence in a south-westerly direction and following the road through Mixenden and passing the side of Mixenden Reservoir to Moor End, thence in a westerly direction to the junction of three lane ends, thence in a south-easterly direction and following the road to where it joins Stocks-lane, thence in a south-westerly direction along Stocks-lane through Luddenden to Luddenden Foot Railway Station, thence following the Lancashire and Yorkshire Railway line through Hebden Bridge, Todmorden, Burnley, and Nelson to Colne Railway Station, thence along the main road from Colne to the point of commencement at the county boundary.

TENDERS FOR LOANS ON TREASURY
BILLS.

1. The Lords Commissioners of His Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank of England, on Monday, the 11th September, at one o'clock, for Treasury Bills to be issued under the Acts 40 Vic., cap. 2, and 52 Vic., cap. 6, to the amount of £2,500,000, viz., £2,000,000 in replacement of Bills falling due on the 17th instant, and £500,000 to complete the replacement of Bills paid off on the 13th May.

2. The Bills will be in amounts of £1,000, £5,000, or £10,000. They will be dated the 16th September, 1905, and will be payable at six months after date, viz. :—on the 16th March, 1906.

3. *The Tenders must specify the net amount per cent. which will be given for the amounts applied for, and the Tenders of private individuals must be made through a London Banker.*

4. The Bills will be issued and paid at the Bank of England.

5. The persons whose Tenders are accepted will be informed of the same on Tuesday, the 12th instant, and payment in full of the amounts of the accepted Tenders must be made to the Bank of England not later than twelve o'clock, on Saturday, the 16th instant.

6. The Lords Commissioners of His Majesty's Treasury reserve the right of rejecting any Tenders.
