

Margaret, Oxford, and upon the remaining sides, that is to say, upon the remaining part of the west, and upon the north, by an imaginary line commencing upon the boundary which divides the said new parish of Saint Margaret, Oxford, from the said district parish of Saint John the Baptist, Summertown, at a point in the middle of Banbury-road, distant two chains precisely to the north of the junction of Staverton-road with Banbury-road, and extending thence northward along the middle of Banbury-road for a distance of ten chains or thereabouts to its junction with Marston Ferry-road, and extending thence eastward along the middle of Marston Ferry-road for a distance of thirty-eight chains or thereabouts to its junction with the footpath leading across Marston Ferry to Marston, and extending thence first north-eastward and then eastward along the middle of the said footpath for a distance of eighteen chains and a quarter or thereabouts to a point where Marston Ferry crosses the middle of the River Cherwell, upon the boundary which divides the said district parish of Saint John the Baptist, Summertown, from the said parish of Marston."

And whereas drafts of the said scheme have, in accordance with the provisions of the hereinbefore mentioned Act, been transmitted to the Patrons and to the Incumbents of the cures out of which it is intended that the district recommended in such scheme to be constituted shall be taken, and such Patrons and Incumbents have respectively signified their assent to such scheme:

And whereas the said scheme has been approved by His Majesty in Council: now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Act; and His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Oxford.

WHEREAS the Ecclesiastical Commissioners for England have in pursuance of the Act of the sixteenth and seventeenth years of Her late Majesty Queen Victoria, chapter fifty, and of the Act of the twenty-third and twenty-fourth years of Her said late Majesty, chapter one hundred and twenty-four, duly prepared and laid before His Majesty in Council a scheme bearing date the second day of November, in the year one thousand nine hundred and five, in the words and figures following, that is to say:—

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the sixteenth and seventeenth years of Her late Majesty Queen Victoria chapter fifty and of the Act of the twenty-third and twenty-fourth years of Her said late Majesty chapter one hundred and twenty-four have prepared and now humbly lay before Your Majesty in Council the follow-

ing scheme for effecting an exchange of the patronage of the benefice (being a vicarage) of Saint Saviour, Ringley, situate in the county of Lancaster and in the diocese of Manchester for the patronage of the benefice (being a vicarage) of Tonge-cum-Alkrington situate in the said county of Lancaster and in the diocese of Manchester.

"Whereas the advowson or perpetual right of patronage of and presentation to the said benefice of Saint Saviour Ringley is vested in the Rector or Incumbent for the time being of the benefice of Bury in the said county and diocese.

"And whereas the advowson or perpetual right of patronage of and presentation to the said benefice of Tonge-cum-Alkrington is vested in the Rector or Incumbent for the time being of the benefice of Prestwich in the said county and diocese.

"And whereas the Venerable Foster Grey Blackburne Archdeacon of Manchester, now Rector or Incumbent of the said benefice of Bury and the Reverend Frederic Wilson Cooper, now Rector or Incumbent of the said benefice of Prestwich, have respectively signified to us their desire that the patronage of the said two benefices of Saint Saviour, Ringley, and Tonge-cum-Alkrington may be rearranged by way of exchange in the manner which is hereinafter recommended and proposed.

"And whereas we have made due enquiry and calculation as to the circumstances and relative value of the said two benefices of Saint Saviour, Ringley, and Tonge-cum-Alkrington and of the patronage thereof respectively and we do hereby certify to Your Majesty in Council that the circumstances and present values of the said two benefices and vicarages are as set forth in the schedule hereunto annexed.

"Now therefore with the consent of the said Foster Grey Blackburne, as such Rector or Incumbent of the said benefice of Bury and with the consent of the said Frederic Wilson Cooper as such Rector or Incumbent of the said benefice of Prestwich (in testimony whereof they have respectively signed and sealed this scheme) we the said Ecclesiastical Commissioners for England humbly recommend and propose that upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this scheme and without any conveyance or assurance in the law other than such duly gazetted Order the whole advowson or perpetual right of patronage of and presentation to the said benefice of Saint Saviour, Ringley, and the church thereof shall be assigned and transferred from the said Foster Grey Blackburne Rector or Incumbent of the said benefice of Bury and from his successors Rectors or Incumbents of the same benefice and shall become and be absolutely vested in and shall and may from time to time and at all times be exercised by the said Frederic Wilson Cooper, Rector or Incumbent of the said benefice of Prestwich, and his successors, Rectors or Incumbents of the same benefice, for ever and that in exchange for the same the whole advowson or perpetual right of patronage of and presentation to the said benefice of Tonge-cum-Alkrington and the church thereof shall in like manner and upon and from the same date be assigned and transferred from the said Frederic Wilson Cooper, Rector or Incumbent of the said benefice of Prestwich, and from his successors, Rectors or Incumbents of the same benefice, and shall become and be absolutely vested in and shall and may from time to time and at all times be exercised by the said Foster Grey Blackburne,
