the same should be assigned to the said church of Saint Stephen, Clapham Park, situate as aforesaid.

"Now therefore, with the consent of the Right Reverend Edward Stuart, Bishop of Southwark, as such Bishop and also as the patron (in right of his See) of the vicarage of the said new parish of Saint Mary Streatham, with the con-sent of the Reverend Charles Philip Greene, of the Rectory, Clapham, in the said county of Surrey, Clerk in Holy Orders, as one of the patrons of the vicarage of the said new parish of All Saints, Clapham Park, and also as one of the patrous of the vicarage of the said new parish of Saint James, Clapham, with the consents of the Reverend Robert Baker Girdlestone, of Warleigh Lodge, Wimbledon, in the said county of Surrey, Clerk in Holy Orders and Honorary Canon of the Cathedral Church of Christ in Oxford, of Eugene Stock, of Glencairn, Southland-road, Bickley, in the county of Kent, Gentleman, of George Anthony King, Esquire, one of the Masters of the Supreme Court of Judicature in England, and of the Reverend Frederick Baylis, of the Church Missionary House, Salisbury-square, in the city of London, Clerk in Holy Orders as the remaining patrons of the said vicarage of All Saints, Clapham Park, and with the consents of the Very Reverend William Hagger Barlow, Doctor in Divinity, Dean of the Cathedral Church of Peterborough, of the Right Reverend Edmund Arbuth-not, Bishop of Manchester, of the Reverend Henry Elliott Fox, of the Croft, Putney, in the said county of Surrey, Clerk in Holy Orders and Prebendary of the Cathedral Church of Saint Paul in London, of the Reverend George Ferris Whidborne, of Hummerwood Lodge, East Grin-stead, in the county of Sussex, Clerk in Holy Orders, of Francis Augustus Bevan, of Number 54, Lombard-street, in the city of London, Banker, and of John Francis William Deacon, of Number 20, Birchin-lane, in the said city of London, Banker, as the remaining patrons of the said Vicarage of Saint James, Clapham, (in testimony whereof they the said consenting parties have respectively signed and sealed this representation), we, the said Ecclesiastical Commis-sioners for England, humbly represent, that it would, in our opinion, be expedient that all those contiguous portions of the said new parish of Saint Mary Streatham, of the said new parish of All Saints, Clapham Park, and of the said new parish of Saint James, Clapham, which are described in the schedule hereunder written, all which portions, together with the boundaries thereof, are delineated and set forth on the map or plan hereunto annexed, should be united and formed into one consolidated chapelry for the said church of Saint Stephen, Clapham Park, situate as aforesaid, and that the same should be named 'The Consolidated Chapelry of Saint

Stephen, Clapham Park.' "We therefore humbly pray that Your Majesty will be graciously pleased to take the premises into Your Royal consideration, and to make such Order in respect thereto as to Your Majesty in Your Royal wisdom shall seem meet.

## "The SCHEDULE to which the foregoing Representation has reference.

"The Consolidated Chapelry of Saint Stephen, Clapham Park, comprising :—

"All those contiguous portions of the new parish (sometime district chapelry) of Saint Mary, Streatham (commonly known as Saint Mary, Balham) of the new parish (sometime particular district) of All Saints, Clapham Park, and of the new parish (sometime district chapelry)

of Saint James, Clapham, all in the county of Surrey and in the diocese of Southwark, which are comprised within and are bounded by an imaginary line commencing upon the boundary which divides the consolidated chapelry of Saint John the Divine, Bedford Hill, Balham, in the said county and diocese, from the new parish of Saint Mary, Streatham aforesaid at the centre of the bridge which carries the Crystal Palace and West End Line of the London Brighton and South Coast Railway over Bedford Hill-road, and extending theuce north-westward along the middle of the last-named road for a distance of seventeen chains or thereabouts to its junction with the road called Balham Hill, and extending thence north-eastward along the middle of the last-named road for a distance of one chain or thereabouts to a point at its junction with Balham-grove upon the boundary which divides the said new parish of Saint Mary, Streatham, from the new parish of the Ascension, Balham Hill, in the county and diocese aforesaid, and extending thence first north-eastward and thence south-eastward along the last-mentioned boundary for a distance of twenty-six chains or thereabouts (thereby following the middle of the said road called Balham Hill and of Ravenswood-road) to the point at the junction of the last-named road with Cavendish-road where the said last-mentioned boundary joins the boundary dividing the said new parish of the Ascension, Balham Hill, from the new parish of All Saints, Clapham Park aforesaid, and extending thence northward along the last described boundary for a distance of seven chains or thereabouts (thereby following the course of Cavendish-road aforesaid) to the point at the junction of the last-named road with Atkins-road where the said last described boundary joins the boundary dividing the said new parish of the Ascension, Balham Hill, from the new parish of Saint James, Clapham aforesaid, and extending theuce north-eastward along the last described boundary for a distance of seventeen and a half chains or thereabouts (thereby still following the course of Cavendish-road aforesaid) to the point where the same road is joined by Poynders-road and extending thence south-eastward along the middle of the lastnamed road for a distance of twenty chains or thereabouts to its junction with Clarence-road and Queen's-road, aud extending thence south-westward along the middle of the said Clarence-road for a distance of nine chains or thereabouts to a point upon the boundary dividing the said new parish of Saint James, Clapham, from the new parish of All Saints, Clapham Park aforesaid, at the junction of the same road with Atkins-road aforesaid with Grove-road and with Thorntonroad and extending thence south - eastward along the middle of the last-named road for a distance of eleven chains or thereabouts to its junction with Hydethorpe-road and extending thence south-westward along the middle of the last-named road for a distance of thirty-four chains or thereabouts to its junction with Cavendish - road aforesaid upon the boundary which divides the said new parish of All Saints, Clapham Park, from the new parish of Saint Mary Streatham aforesaid and extending thence south-eastward along the middle of Cavendishroad aforesaid for a distance of fourteen chains or thereabouts to the centre of the bridge which carries the said Crystal Palace and West End Line of the London, Brighton and South Coast Railway aforesaid over the said Cavendish-road and extending thence south-eastward along the middle of the said line of railway for a distance of eighteen chains or thereabouts to the point upon the boundary which divides the parish of
