The Board of Trade have received, through the Secretary of State for Foreign Affairs, a copy of the following Notice, dated December 6, which appeared in the "Moniteur Belge," respecting the imposition of sanitary measures on arrivals from Chinde (Africa) from December 10th, owing to the existence of bubonic plague at that port:—

Peste à Chinde.

Le Ministre de l'agriculture,

Vu l'arrêté royal du 5 avril 1897, relatif à la peste;

Vu l'existence de la peste, officiellement constatée à Chinde (côte orientale d'Afrique),

Arrête :

Art 1er. Les dispositions qui font l'objet des articles 1er à 4 de l'arrêté royal du 5 avril 1897, susvisé, sont rendues applicables, à partir du 10 décembre, aux provenances de Chinde, contaminé par la peste bubonique.

Art. 2. Ces provenances, arrivant par mer, seront soumises, à la station sanitaire de l'Escaut et dans les ports d'Ostende et de Nieuport, ainsi qu'à Selzaete, au régime stipulé par les chapitres II, III et IV du règlement sanitaire général annexé à la Convention sanitaire internationale de Venise, en date du 19 mars 1897.
