# Revocation of Existing Regulations.

2. The powers of the Local Authorities of any district comprised in the Schedule hereto to make regulations under the Swine-Fever Order of 1894, as to movement, exposure, or sale of swine, shall be suspended during the operation of this Order, and all such regulations in force at the commencement of this Order shall thereupon cease to operate.

3. This Order shall come into operation on the ninth day of January, nineteen hundred and six.
