OF NO. AND DISTRICT FAREHAM PROHIBITION FEVER) MENT (AMENDMENT) ORDER OF 1906.

The Board of Agriculture and Fisheries, by virtue and in exercise of the powers vested in them under the Diseases of Animals Acts, 1894 to 1903, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

Movement with Licence direct to Bacon Fuctory or Slaughterhouse.

- 1. The Fareham and District (Swine-Ferer) Prohibition of Movement Order of 1905 shall not, after the commencement of this Order, apply to, or be deemed to prohibit, the movement of swine direct to a bacon factory or slaughterhouse, if accompanied by a Licence authorising such movement granted by an Inspector of the Local Authority of the district in which the becon factory or slaughterhouse is situate, and subject to the following conditions, namely:-
 - (i.) The swine shall be marked by and at the expense of the owner by the painting with an indelible composition of red colour of a broad line down the back and another broad line across the loins of each of the swine thus +, each line being not less than nine inches long;
 - (ii.) The swine shall, so far as is practicable, be moved by railway, and during such movement shall not be permitted to come in contact with swine not marked under this Article;

(iii.) The swine shall, while being moved along, over, or across any highway or thoroughfare, be confined in a van or float;

(iv.) The swine shall after their arrival at the bacon factory or slaughterhouse be there detained until they are slaughtered.
