Powerscourt-road (thereby crossing the boundary which divides the said new parish of Saint Mark, Portsea, from the said new parish of Saint James, Milton) for a distance of thirty-two chains or thereabouts to the junction of Powerscourt-road with Paulsgrove-road, and extending thence northward along the middle of Paulsgrove-road for a distance of eleven chains or thereabouts to its junction with Chichester-road, and extending thence eastward along the middle of Chichester-road for a distance of twenty-one chains and a half or thereabouts, to its junction with Copnor-road, and extending thence northward along the middle of Copnor-road for a distance of one chain or thereabouts to a point opposite to the western end of the fence which divides the close numbered 74 upon the map which is annexed to this representation from the close numbered 75 upon the said map, and extending thence eastward to and along the said fence and along the fence which divides the said close numbered 74 from the close numbered 76 upon the said map for a distance of 10 chains or thereabouts to the point where the last-mentioned fence meets the fence which divides the last-mentioned closes from the close numbered 95 upon the said map, and extending thence due eastward and in a straight line for a distance of twenty yards or thereabouts to a point in the middle of the Portsmouth line of the London, Brighton, and South Coast and the London and South-Western Railways, and extending thence south-westward along the middle of the said line of railway for a distance of thirty-three chains or thereabouts to the centre of the level crossing which carries such line of railway over the roadway which connects Tangier-lane with New-road upon the boundary which divides the said new parish of Saint James, Milton, from the said parish of Portsea, and extending thence first north-westward and then south-westfirst north-westward and then south-west-ward along the middle of New-road (thereby following first the last-mentioned boundary and then the boundary which divides the said parish of Portsea from the said new parish of Saint Mark, Portsea) for a distance of fifty-one chains or thereabouts to the junction of New-road with Kingston-road, and extending thence southward along the middle of Kingston-road for a distance of two chains and a half or thereabouts to its junction with Sultan-road, and extending thence westward along the middle of Sultan-road (thereby crossing the boundary which divides the said parish of Portsea from the said district chapelry of All Saints, Portsea) for a distance of twelve chains and three-quarters or thereabouts to the junction of Sultan-road with School-lane, and extending thence northward along the middle of School-lane for a distance of fifteen chains or thereabouts to its junction with Elm-road, and extending thence north - westward along the middle of Elm-road for a distance of eight chains or thereabouts to its junction with Gamble-road, and extending thence first northward and then north-eastward along the middle of Gamble-road for a distance of eleven chains and a half or therexbouts to its junction with Kingston-crescent, and extending thence eastward along the middle of Kingston-crescent for a distance of six chains (thereby towards the end following the boundary which divides the said parish of Portsea from the said new parish of Saint Mark, Portsea) to the junction of Kingstoncrescent with Kingston-road, at which point the said imaginary line commenced."

And whereas the said representation has been approved by His Majesty in Council: now, therefore, His Majesty, by and with the advice

of His said Council, is pleased hereby to ratify the said representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Winchester.

The KING's Most Excellent Majesty in Council.

WHEREAS the Ecclesiastical Commissioners for England have in pursuance of the Act of the eighth and ninth years of Her late Majesty Queen Victoria, chapter seventy; of the Act of the fourteenth and fifteenth years of Her said late Majesty, chapter ninety-seven; and of the Act of the nineteenth and twentieth years of Her said late Majesty, chapter fifty-five; duly prepared and laid before His Majesty in Council a representation, bearing date the eighteenth day of January, in the year one thousand nine hundred and six, in the words and figures following; that is to say:—

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the eighth and ninth years of Her late Majesty Queen Victoria, chapter seventy, of the Act of the fourteenth and fifteenth years of Her said late Majesty, chapter ninety-seven, and of the Act of the nineteenth and twentieth years of Her said late Majesty, chapter fifty-five, have prepared, and now humbly lay before Your Majesty in Council the following representation as to the assignment of a consolidated chapelry to the consecrated church of Saint Bartholomew, Battersea, situate within the new parish (sometime consolidated chapelry) of Saint Philip, Battersea, in the county of Surrey and in the diocese of Southwark.

"Whereas at certain extremities of the said new parish of Saint Philip, Battersea, and of the new parish (sometime district chapelry) of Saint Paul, Clapham, in the said county and diocese, which said extremities lie contiguous one to another, and are described in the schedule hereunder written, there is collected together a population which is situate at a distance from the several churches of such new parishes.

"And whereas it appears to us to be expedient that certain contiguous portions (being the portions containing the population aforesaid) of the said new parish of Saint Philip, Battersea, and of the said new parish of Saint Paul, Clapham, should be formed into a consolidated chapelry for all ecclesiastical purposes, and that the same should be assigned to the said church of Saint Bartholomew, Battersea, situate as aforesaid.

"Now, therefore, with the consent of the Right Reverend Edward Stuart, Bishop of Southwark, as such Bishop, and as the patron (in right of his see) of the vicarage of the said new parish of Saint Philip, Battersea, and with the consent of the Reverend Charles Philip Greene, Rector or Incumbent of the rectory of the parish of Clapham, in the county and diocese aforesaid, and as such Rector or Incumbent the
