The following Statute, made on the twenty-eighth day of February, one thousand nine hundred and six, by the Governing Body of Queen's College, Oxford, and sealed on the sixteenth day of March, one thousand nine hundred and six, has been submitted for the approval of His Majesty in Council, and notice of its having been so submitted is published in accordance with the provisions contained in "The Universities of Oxford and Cambridge Act, 1877":—

At a General Meeting of the Governing Body of the Queen's College in the University of Oxford, specially summoned for the purpose and held on the twenty-eighth day of February, one thousand nine hundred and six, by the unanimous votes of the persons present and voting, the following Statute altering a Statute made by the Commissioners under the provisions of the Universities of Oxford and Cambridge Act, 1877, was made, and ordered to be submitted to His Majesty the King in Council to be dealt with as provided in the said Act:—

STATUTE.

In the Statutes made by the Commissioners for Queen's College, Stat. XIII, 1, after the words "in any year" the figures "500" shall be struck out and the figures "1000" substituted for them.

The following Statute made by the Governing Body of Merton College, Oxford, on the third day of March, one thousand nine hundred and six (and sealed on the sixth day of March, one thousand nine hundred and six), has been submitted for the approval of His Majesty in Council, and notice of its having been so submitted is published in accordance with the provisions of

"The Universities of Oxford and Cambridge Act, 1877":—

The Warden and Fellows of Merton College, Oxford, respectfully submit to His Majesty the King in Council the new Statute (sent herewith), which was passed on March third, one thousand nine hundred and six, at a General Meeting of the Governing Body of the College, specially summoned for that purpose, by the votes of not less than two-thirds of the number of persons present and voting, in accordance with the provisions of "The Universities of Oxford and Cambridge Act, 1877," section 54.

At a General Meeting of the Governing Body of Merton College, held on March third, one thousand nine hundred and six, it was resolved to make the following Statute amending Statute V, 3 (b):—

"There shall be paid to each Tutor and Lecturer regularly employed in the service of the College the annual stipend of one hundred pounds out of the general revenues of the College, in addition to his emoluments (if any) as Fellow, and such additional stipend as may be awarded to him by the College out of the Tuition Fund: Provided that the number of persons receiving such annual stipend of one hundred pounds shall never exceed nine."

THE following Statute made by the University of Cambridge has been submitted for the approval of His Majesty in Council, and notice of its having been so submitted is published in accordance with the provisions contained in "The Universities of Oxford and Cambridge Act, 1877":—

STATUTE to alter a Statute for the University of Cambridge and now submitted for the approval of His Majesty the King in Council under the Universities of Oxford and Cambridge Act, 1877.

We the Chancellor, Masters, and Scholars of the University of Cambridge, in pursuance and in exercise of the powers given to us by the 53rd section of the said Act do hereby alter Statute A for our said University in manner following:—

By substituting in Chapter II Degrees, Section 19, Affiliated Colleges, for paragraph 2 of such Section the following paragraph to form an amended paragraph 2 of Section 19 of the same Chapter:—

"Students of the institution who shall have continued Members of it for such length of time, not less than two years, and shall have attended such lectures and passed such examinations as may be required from time to time by Grace of the Senate, shall if admitted as Members of the University, be deemed, for such purposes and under such conditions as the Senate may from time to time by Grace determine to have already kept by residence one or more terms (not exceeding three in number)."
