(Supplementary to the General Regulations respecting Open Competitive Examinations for situations in the Civil Service included in Schedule A of the Order in Council of 4th June, 1870.)

# N.B.—These Regulations are liable to alteration for future Examinations.

1. The limits of age for this situation are 19 and 22. If an examination begins in one of the first six months of any year, candidates must be of the prescribed age on the first day of May in that year. If an examination begins in one of the last six months of any year, candidates must be of the prescribed age on the first day of November in that year.
