# **REGISTRATION OF BIRTHS AND DEATHS.**

Notice is hereby given, that in pursuance of the provisions of the twenty-first section of an Act passed in the thirty-eighth year of the reign of Her late Majesty, intituled "The Births and Deaths Registration Act, 1874," I, Sir William Cospatrick Dunbar, Bart, C.B., Registrar-General of Births, Deaths, and Marriages in England, have, with the sanction of the Local Government Board, erdered and declared that, on and after the first day of July next, in order to improve registration arrangements in Sculcoates Registration District, with due regard to the boundaries of the Wards of Kingston-upon-Hull county borough, the following changes shall be made in the constitution of Sub-Districts of that Registration District, viz:---(a) Sutton and Newland Sub-Districts shall be abolished; (b) a Sub-District shall be created to be called and known as Southcoates Sub-District and to consist of the rural civil parish of Sutton, and of the part of Southcoates Ward now situated in Sutton Sub-District, together with the remaining and principal part of Southcoates Ward to be detached from Drypool Sub-District; (c) the parts of Beverley Ward, now respectively situated in West Sculcoates and Newland Sub - Districts, together with the part of East Central Ward now situated in the former Sub-District, shall be transferred to East Sculcoates Sub-District in which the other parts of these Wards are included, and which, with the exclusion of the part of Paragon Ward next referred to, will then consist of the entire East Central and Beverley Wards; (d) Newland Ward now included in Newland Sub-District, and the part of Paragon Ward now included in East Sculcoates Sub-District shall be transferred to West Sculcoates Sub-District, which will then consist of the entire West Central, Park, and Newland Wards, and of all that part of Paragon Ward comprised in Sculcoates Union; (e) the parts of Alexandra and Drypool Wards now respectively situated within Hedon and Sutton Sub-Districts shall be transferred to Drypool Sub-District, which will then consist of the entire Alexandra and Drypool Wards.—Witness my hand this 14th day of June, one thousand nine hundred and six.

## INCOME TAX.
