

transferred to and annexed to the United Benefice, and the Incumbent of the said United Benefice and his successors shall be entitled to retain an annual sum of three hundred and sixty-seven pounds six shillings and eightpence out of the income arising from or constituting such endowments, and that the residue of such income shall form the endowment or part of the endowment of the new district which is hereinafter proposed to be constituted or created and such residue of the income of the United Benefice shall from time to time be paid by the Incumbent of the said United Benefice by half-yearly payments to the Minister or Incumbent of such new district or until such new district shall have been constituted or created to us the said Ecclesiastical Commissioners to be accumulated by us towards the endowment of such new district.

"2. That upon the union taking effect the parsonage house of the vicarage of Saint Bride, Fleet-street, with Bridewell shall become the parsonage house of the United Benefice.

#### " PART IV.

"As to a certain new district, we, the said Ecclesiastical Commissioners, further recommend and propose—

"1. That an ecclesiastical district within the limits of the metropolis or within the vicinity of the metropolis as defined by the herebefore-mentioned Act of the sixty-first and sixty-second years of Her said late Majesty, chapter twenty-three (such district having then been, or being then, about to be formed, or legally constituted under some or one of the Acts of Parliament relating to the Ecclesiastical Commissioners for England, authorizing the formation or constitution of such district) shall be selected by the Bishop of London as the district for which a church shall be built out of the proceeds of the sale or sales hereinafter recommended.

"2. That the whole patronage of such new district and benefice shall be vested in the Bishop of London for the time being.

"3. That the sum of one thousand five hundred pounds now held by the said Ecclesiastical Commissioners towards the provision of a parsonage house for the said benefice of the Holy Trinity, Gough-square, together with any accumulations of interest thereon which may accrue after the date of the union taking effect shall be applied by us to the provision of a parsonage house for such new district and benefice in the manner contemplated by clause three of Part V of this scheme.

#### " PART V.

"As to the church of the Holy Trinity, Gough-square, and the site and appurtenances thereof, and as to the proceeds of any sale or sales of the materials, site, furniture, or fittings of the same church, we, the said Ecclesiastical Commissioners, recommend and propose:—

"1. That upon the union taking effect, the church of the Holy Trinity, Gough-square, be taken down.

"2. That the materials and site of the said church, together with any ground annexed thereto and necessary for the use or enjoyment thereof, shall, together with any such furniture or fittings which shall not have been appropriated in the manner contemplated by clause two of Part II of this scheme, be sold and disposed of by us, the said Ecclesiastical Commissioners, at such time or times and in such manner in all respects as to us shall seem expedient, such sale or disposal being made in all respects subject to the provisions contained in the seventeenth section of the said Act of the twenty-

third and twenty-fourth years of Her said late Majesty, chapter one hundred and forty-two.

"3. That the net proceeds to arise from the sale or sales to be made by us, the said Ecclesiastical Commissioners, as aforesaid, of the site and materials and furniture or fittings of the said church shall form one aggregate fund, and shall after the transfer from it to the fund created under the twenty-second section of the said Act of the twenty-third and twenty-fourth years of Her said late Majesty, chapter one hundred and forty-two, of a sum of one thousand pounds, and after the payment of the gratuities (if any) to be granted by us under clause six of Part II of this scheme, be applied for or towards the acquisition of a suitable site for, and the erection of a new church within the limits of the said new district, constituted or to be constituted as aforesaid, and as the church of such new district; and if the amount of such fund shall be sufficient, for or towards the acquisition of a suitable site for, and the erection of a parsonage house (or the purchase, enlargement, or alteration of any existing house suitable, with or without enlargement or alteration for a parsonage house) within the limits of the said new district constituted or to be constituted as aforesaid, and as the parsonage house of such new district, and the remainder (if any) of such aggregate fund shall be added to the said fund created under the twenty-second section of the said Act of the twenty-third and twenty-fourth years of Her said late Majesty, chapter one hundred and forty-two.

#### " PART VI.

"Upon the subject of the patronage of the United Benefice we, the said Ecclesiastical Commissioners, recommend and propose:—

"That the whole patronage of the United Benefice shall be vested in the Dean and Chapter of the collegiate church of Saint Peter, in Westminster.

"Provided always that this scheme shall not take effect until the consents and approvals which by the seventeenth section of the said Act of the twenty-third and twenty-fourth years of Her said late Majesty, chapter one hundred and forty-two, are made requisite to the sale or letting or appropriation under the powers conferred by that Act of the site of any church shall be obtained to the sale and appropriation hereby proposed of the church of the Holy Trinity, Gough-square, and of the site thereof together with any ground annexed thereto and necessary for the use and enjoyment thereof and to the mode of dealing with such site which is hereby proposed.

"And provided also that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid or any of them in accordance with the provisions of the said Acts or of either of them or of any other Act of Parliament."

And whereas the said scheme has been laid before both Houses of Parliament for the space of two calendar months.

And whereas the said scheme has been approved by His Majesty in Council: now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of London.
