The KING taking into His Royal consideration that, upon the decease of Henry Cyril, Marquess of Anglesey, which happened on the fourteenth day of March One thousand nine hundred and five, the title and dignity of Marquess of Anglesey devolved upon Charles Henry Alexander, now Marquess of Anglesey, as the eldest son and heir of the late Alexander Victor Paget (commonly called Lord Alexander Victor Paget) who was the brother of Henry 4th Marquess of Anglesey, and that according to the ordinary rules of honour, the brother and sisters of the said Charles Henry Alexander, Marquess of Anglesey, cannot enjoy that title, rank, place and precedence which would have been due to them had their said late father survived his nephew the said Henry Cyril, Marquess of Anglesey and thereby succeeded to the title and dignity of Marquess of Anglesey: His Majesty has been graciously pleased to ordain and declare that Victor William Paget, a minor, Winifred Constance Hester, wife of Charles John Alton Chetwynd Talbot (commonly called Viscount Ingestre) and Beatrice Eleanor, wife of Reginald Herbert (commonly called Lord Herbert) Member of the Fifth Class of Our Royal Victorian Order, the brother and sisters of the said Charles Henry Alexander Marquess of Anglesey, shall henceforth have, hold and enjoy the same title, place, pre-eminence and precedence as if their late father, the said Alexander Victor Paget had survived his nephew, the said Henry Cyril Marquess of Anglesey, and had thereby succeeded to the said title and dignity of Marquess of  $\mathbf{Anglesey.}$
