ORDER OF THE BOARD OF AGRICULTURE AND FISHERIES.

(DATED 6TH AUGUST 1906.).

The Board of Agriculture and Fisheries, by virtue and in exercise of the powers vested in them under the Diseases of Animals Acts, 1894 to 1903, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

1. Notwithstanding the provisions of the Swine-Fewer (Regulation of Movement), Order of 1903, or of any Order by which such provisions are applied to any scheduled area, swine may be moved to the exhibition mentioned in the Schedule hereto, and from such exhibition to any place of destination in Great Britain situate in any scheduled area, if accompanied by a Licence authorising such movement.

2. In the case of movement to the said exhibition the Licence shall be one granted by some person authorised in that behalf by the Hertfordshire County Council, and in the case of movement from the said exhibition the Licence shall be one granted by an Inspector of the Local Authority of the District in which the place of destination is situate.

3. The swine shall be moved by the nearest available route and without unnecessary delay to the exhibition or place of destination specified in the Licence and not elsewhere, and while being so, moved shall not be subject to Regulations made by a Local Authority under any Order of the Board relating to Swine-Fever.

Drinkwater Point—Light.and Light-buoy replaced by Light-vessel.

With reference to Notice to Mariners, No. 654 : of 1906 :---

The Chinese Government has given notice, dated 22nd May, 1906, that on or about July 1st

a Light-vessel, exhibiting a white occulting dioptric light every ten seconds, thus ——light, five seconds; eclipse, five seconds, would be established in a position about 3 miles N. 83° W. from Drinkwater Point Light and Bell Buoy; the light, which is of the 4th order, is elevated 35 feet above the sea, and visible in clear weather from a distance of 11 miles; the vessel is iron, painted red, marked "Drinkwater Point," and has an iron column surmounted by the lantern. During thick or foggy weather a bell will be struck once every fiftcen seconds.

Approximate position, lat. 34° $24\frac{1}{2}$ ' N., long. 121° $56\frac{1}{2}$ ' E.

Should this light-vessel be out of position, the light will not be exhibited, but a red fixed light will be shown from each end of the vessel at night, and a red flag displayed by day.

On the establishment of the above light-vessel, the white group flashing light on Drinkwater Point and Drinkwater Point Light and Bell Buoy will be discontinued.
