

proceeding in a northerly and easterly direction along the same boundary line to a point where such boundary line is intersected and crossed by Hyndburn-road, thence in an easterly direction along that road to its junction with Lister-street, thence in a southerly direction along that street across Blackburn-road and along Grant-street to the said railway and thence in a westerly direction along the northerly side of the said railway to the point first above described.

No. 2.—Central Ward.

I do hereby determine that Central Ward shall comprise so much of the said township and borough of Accrington as lies within the following boundary:—

Commencing at a point on the westerly boundary of the said borough where such boundary line is intersected and crossed by Hyndburn-road, thence along such boundary line in a northerly direction to a point where such boundary line is intersected by a fence due west of the northerly side of the public park, known as Milnshaw Gardens, thence in a straight line in an easterly direction along the northerly side of the said public park to a new or intended street called Sunflower-street, thence in a southerly direction along that street to its junction with a back road or street on the southerly side of Peel Mill, thence along that back road or street to its junction with Argyle-street, thence in a northerly direction along that street to its junction with York-street, and thence in an easterly direction along York-street to its junction with Whalley-road, thence in a southerly direction along Whalley-road to its junction with Blackburn-road, thence in a westerly direction along that road to its junction with Church-street, thence in a southerly direction along that street to its junction with Wellington-street, thence along that street to its junction with Cotton-street, thence in a southerly direction along that street to a point opposite Nelson-street, and thence in a westerly and southerly direction along Back Cotton-street to a point in that street nearest to the Accrington and Manchester branch of the said railway, and thence in a straight line due west to the westerly side of the said railway, thence in a northerly direction along the westerly side of the said railway to a point where the railway crosses over Ormerod-street, thence in a north-westerly direction along the south-westerly side of the Goods Station to a point where the railway crosses over Scatcliffe-street, thence across to the northerly side of the Accrington and Blackburn branch of the said railway, and thence in a westerly direction along the northerly side of the said railway to a point opposite Grant-street, thence in a northerly direction along that street, across Blackburn-road and along Lister-street, to its junction with Hyndburn-road, and thence in a westerly direction along that road to the point first above described.

No. 3.—North Ward.

I do hereby determine that North Ward shall comprise so much of the said township and borough as lies within the following boundary:—

Commencing on the westerly boundary of the said borough at a point where such boundary line is intersected by a fence due west of the northerly side of the public park known as Milnshaw Gardens, thence in a northerly direction along the westerly boundary line of the said borough to a point where it meets the boundary line of the township of Altham, thence in an easterly direction along the northerly boundary line of the said borough to a point where it meets the

boundary line of the township of Huncoat, thence in a southerly and south-easterly direction along the north-easterly boundary line of the said borough to a point where such line is intersected and crossed by the Accrington and Burnley branch of the said railway, and thence in a south-easterly direction along the north-easterly boundary line of the said borough to a point where such boundary line would be intersected by Manor-street, if, and when, that street is extended thereto, thence in a south-westerly direction along that street to its junction with Sydney-street, thence in a westerly direction along that street to its junction with Burnley-road, thence in a south-westerly direction along that road to its junction with Whalley-road, thence in a north-westerly direction along that road to its junction with York-street, thence in a westerly direction along that street to a point opposite Argyle-street, thence in a southerly direction along Argyle-street to its junction with a back road or street on the southerly side of Peel Mill, thence in a westerly direction along that back road or street to its junction with Sunflower-street, thence in a northerly direction along that street to a point opposite the northerly side of the said public park known as Milnshaw Gardens, and thence in a westerly direction along the northerly side of the said public park to the point first above described.

No. 4.—Peel Park Ward.

I do hereby determine that Peel Park Ward shall comprise so much of the said township and borough as lies within the following boundary:—

Commencing at a point on the north-easterly boundary of the said borough, where such boundary would be intersected by Manor-street, if, and when, that street is extended thereto, thence in a south-easterly, north-easterly and south-easterly direction along the said boundary line to a point where such boundary line would be intersected by Hodder-street, if, and when, that street is extended thereto, thence in a south-westerly direction in a straight line to and along that street to its junction with Clarendon-street, thence in a north-westerly direction along that street to its junction with Cedar-street, thence in a south-westerly direction along that street to its junction with Park-street, thence in a south-westerly direction across Park-street and along a short back street or passage to Gillies-street, to a point opposite its junction with Barnes-street, thence in a south-westerly direction along that street to its junction with Abbey-street, thence in a north-westerly direction along that street to its junction with Burnley-road, thence in a north-easterly direction along that road to its junction with Sydney-street, thence in a south-easterly direction along that street to its junction with Manor-street, and thence in a north-easterly direction along that street to the point first before described.

No. 5.—East Ward.

I do hereby determine that East Ward shall comprise so much of the said township and borough as lies within the following boundary:—

Commencing at a point on the north-easterly boundary of the said borough where such boundary line would be intersected by Hodder-street, if, and when, such street is extended thereto, thence in a south-easterly, easterly, southerly, westerly, and southerly direction along the said boundary line to the stream of water flowing down Warmden Clough and known as Warmden Brook, thence in a westerly irregular line along the said Warmden Brook to a point at Broad Oak Print Works, where such brook is crossed
