THE FAIRS ACT, 1873.

HUCKNALL-UNDER-HUTHWAITE FAIR OR FEAST.

Whereas on the 18th August, 1906, a representation was made to me, as Secretary of State for the Home Department by the Urban District Council of Hucknall-under-Huthwaite to the effect that a Fair or Feast has been held annually at Hucknall-under-Huthwaite on the Saturday preceding the third Sunday in July and the two following days, and that it would be for the convenience and advantage of the public that the said Fair or Feast should in future be held on the Saturday preceding the first Sunday in September and the two following days:

And whereas notice of the said representation and of the time when the same would be taken into consideration has been duly published in pursuance of the Fairs Act, 1873:

And whereas on such representation and consideration it appears to me that it would be for the convenience and advantage of the public that the said Fair or Feast should in future be held on the Saturday preceding the first Sunday in September and the Monday and Tuesday following:

Now therefore I, as Secretary of State for the Home Department, in exercise of the powers vested in me by the Fairs Act, 1873, do hereby order that the Fair or Feast, which has been held annually at Hucknall-under-Huthwaite on the Saturday preceding the third Sunday in July and the Monday and Tuesday following, shall in future be held annually on the Saturday preceding the first Sunday in September and the Monday and Tuesday following.
