SURREY (SWINE-FEVER) ORDER OF 1906 (No. 2).

The Board of Agriculture and Fisheries, by virtue and in exercise of the powers vested in them under the Diseases of Animals Acts, 1894 to 1903, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

Contraction of Limits of Swine-Fever Infected

1. The limits of the Swine-Fever Infected Area declared by Order of the Board dated the twentythird day of April, nineteen hundred and six, are hereby contracted so as to comprise only the Area described in the Schedule to this Order, and the Arca so described is hereby from and after

the commencement of this Order declared to be an area infected with swine-fever for the purposes of the Swine-Fever (Infected Areas) Order of 1902 as modified by the Surrey (Swine-Fever) Order of 1906.

Commencement.

2. This Order shall come into operation on the twenty-ninth day of October, nineteen hundred and six.

WANDSWORTH UNION.

To the Guardians of the Poor of the Wandsworth Union ;-

And to all others whom it may concern.

Whereas by a General Order dated the 14th day of December, 1852, addressed to the Guardians of the Poor of certain Unions and Parishes, including the Wandsworth and Parishes, including the Wandsworth and Clapham Union (now known as the Wandsworth Union), the Poor Law Board prescribed Regulations with regard to the administration of out-door relief to poor persons in the said Union:

And whereas by an Order dated the 6th day of January, 1906 (hereinafter referred to as "the Order"), We, the Local Government Board, made temporary provision with regard to the administration of relief to certain classes of poor persons in the said Union, and by Article III of the Order provided that the Order should operate and have effect during a period not exceeding six calcudar months from the date of the Order;

And whereas it is expedient that such further provision as is hereinafter set forth should be made in relation to the subject-matter of the Order;

Now therefore, in pursuance of the powers given to Us by the Statutes in that behalf, We do hereby Order that notwithstanding anything in the Order, the provisions thereof shall be in force and shall have effect during a further period not exceeding six calendar months from the date of this Order.
