ORDER of the Local Government Board: Motor Car Act, 1903: Regulation under Section 8.

COUNTY OF WESTMORLAND. Parish of Heversham.

To the County Council of Westmorland;—
And to all others whom it may concern.

Whereas by section 8 of the Motor Car Act, 1903, it is provided that We, the Local Government Board, may, by Regulations made under Section 6 of the Locomotives on Highways Act, 1896, restrict the driving of any

motor cars, or of any special kind of motor cars, on any specified highway, or part of a highway, which does not exceed sixteen feet in width, or on which ordinary motor car traffic would, in Our opinion, be especially dangerous;

And whereas the County Council of Westmorland, having applied to Us to make a Regulation in pursuance of the above-mentioned sections prohibiting the driving of motor cars on a certain highway known and hereinafter referred to as Low-road, Leasgill, and situate within the parish of Heversham, in the county of Westmorland, We directed a Local Inquiry to be held into the matter by one of Our Inspectors, and an Inquiry was held accordingly, and Report has been made to Us thereon:

Now therefore, after consideration of the said Report, and of all the circumstances of the case, We, the Local Government Board, in pursuance of Our powers in that behalf, do hereby make the following Regulations:—

ARTICLE I.—A person shall not drive a motor car on the highway known as Low-road, Leasgill, at a speed exceeding five miles per hour.

ARTICLE II.—These Regulations shall come into operation on the nineteenth day of November, one thousand nine hundred and six.

I, Henry Bradley Harrison-Broadley, of Welton House, in the East Riding of the county of York, an owner of lands, tenements, and hereditaments, situate in the townships of Hunsley, Little Weighton (or Weeton), and Riplingham, or elsewhere in the parish of Rowley, in the East Riding of the county of York, out of which certain sums of money by way of corn rent in lieu of tithes are now issuing, do under or by virtue of an Act of Parliament for the enclosure of land in the East Riding of Yorkshire, passed in the 41st year of the reign of His Majesty King George III, and the Awards made in pursuance thereof, hereby give notice, that I intend to apply to the Court of Quarter Sessions of the Peace to be holden at Beverley for the said East Riding in the first week after the next Epiphany, namely, on the first day of January, 1907, to have three persons nominated and appointed by the Justices then and there assembled to be Arbitrators or Referees for inquiring into and ascertaining the average price of a Winchester bushel of good marketable wheat for the twenty-one years then last past in order that such alteration may be made at the following Quarter Sessions for the said Riding in the amount of the corn rent in lieu of tithes issuing or payable out of the lands, tenements, and hereditaments situate in the parish of Rowley and townships of Hunsley, Little Weighton (or Weeton), and Riplingham aforesaid as the Court in pursuance of the said Act may direct.—As witness my hand this first day of November, 1906.
