### THE MOTOR CAR ACT, 1903.

# County of West Suffolk.

HEREAS by sub-section (1) of section 9 of the Motor Car Act, 1903, it is enacted that within any limits or place referred to in regulations made by the Local Government Board with a view to the safety of the public, on the application of the local authority of the area in which the limits or place are situate, a person shall not drive a motor car at a speed exceeding ten miles per hour:

And whereas the County Conncil of West Suffolk have made application to the Local Government Board for a regulation to be made in pursuance of the said sub-section putting the above-mentioned provisions of that sub-section in force within the limits comprising the following parts of roads within the urban district of Newmarket, that is to say, (a) Bury-road, from the Toll Gate to its junction with High-street, and (b) High-street from its junction with Buryroad to the Cemetery on the Cambridge-road :
