No. 1261—UNITED STATES-GULF OF MEXICO.

Florida, Alabama, and Mississippi Coasts—List of Lights Damaged or Destroyed,

With reference to Notice to Mariners No. 1220 of 1906:—

The United States Government has given further notice, dated 12th October, 1906, containing an additional list of the lights on the coasts of Florida, Alabama, and Mississippi damaged or destroyed by a recent hurricane, as follows:—

1. St. George's Sound, West Pass. The front red fixed leading light formerly situated on the south-eastern point of St. Vincent Island.

Approximate position, lat. 29° 38' N., long. 85° 6' W.

#### 2 PENSACOLA BAY.

- a. Deer Point White Fixed Light, formerly situated at a distance of  $6\frac{1}{2}$  miles East from Pensacola Lighthouse.
- b. Bar Beacon White Fixed Front Light, formerly situated at a distance of one cable S. 25° E. from Pensacola Light. This light will not be re-established.
- c. Fort Mc. Ree Breakwater Red Fixed Light, formerly situated at a distance of  $1\frac{2}{10}$  miles S. 5° W. from Pensacola Light.
- d. Fort Mc. Ree Rear White Fixed Light, formerly situated at a distance of 11 miles S, 8° W, from Pensacola Light.

- e. Fort Barraneas White and Red Fixed Leading Lights, formerly situated at a distance of  $3\frac{1}{2}$  cables eastward from Pensacola Light.
- f. Middle Beacon Red Fixed Light in approximately lat. 30° 28′ N., long. 87° 2′ W.

Approximate position, Pensacola Light, lat. 30° 20¾′ N., long. 87° 18½′ W.

[Variation 3° Easterly in 1906.]

2. Horn Island Pass.

The fixed and red flashing light on the eastern end of Horn Island.

Approximate position, lat. 30°  $13\frac{1}{2}$ ′ N., long. 88° 32′ W.

Also, the red fixed light on the beacon, situated  $1\frac{7}{10}$  miles to the eastward of the above light.

3. Round Island Spit Lights; the beacon lights formerly situated at distances of 2½ miles S. 22° W. and 3½ miles N. 55° W. respectively from Round Island Light.

Approximate position, Round Island Light, lat.  $30^{\circ} 17\frac{1}{2}'$  N., long.  $88^{\circ} 35\frac{1}{2}'$  W.

# [Variation 4° Easterly in 1906.]

- 4. Pascagoula River White Fixed Light, formerly situated in approximately lat. 30° 21½′ N., long. 88° 34½′ W.; together with the leading and beacon lights for entering, and the lights for navigation of the Pascagoula River.
- 4. Ship Island. The red and white fixed leading lights for South Channel formerly situated about one cable to the southward and westward respectively of Ship Island Lighthouse.

Approximate position, Ship Island Lighthouse, lat. 30° 13′ N., long. 88° 58′ W.

5. Gulf Port. The three red fixed beacon lights marking the dredged channel to Gulf Port.

Approximate position of South Light, lat. 30° 164' N., long. 89° 1' W.

6. Mississippi River, South-western Bank.— The Jump White Fixed Beacon Light.

Approximate position, lat. 29°  $16\frac{1}{2}$ ′ N., long. 89° 21′ W.

Some of the above lights have been replaced by temporary lights of the same character, but the permanent lights will be re-established as soon as possible.
