In the following instances the tramways will be laid along the several streets and roads hereinafter mentioned, so that for a distance of 30 feet, or upwards, a less space than 9 feet 6 inches will intervene between the outside of the footpath on the sides or side hereinafter mentioned of the streets or roads and the nearest rail of the tramway:—

Tramway No. 1-

In South Accommodation-road-

- (a) On both sides, from a point 7 yards west of the intersection of the centre lines of Orchardstreet and South Accommodation-road for a distance of 50 yards, measured in an easterly direction.

(c) On the south-easterly side, from a point 13 yards west of the intersection of the centre lines of John Eaton-street and South Accommodation-road for a distance of 176 yards, measured in a north easterly direction.

(d) On both sides from a point 7 yards north of the intersection of the centre lines of Prospect-avenue and South Accommodation-road for a distance of 50 yards, measured in a northerly direction.

Tramway No. 2-

(a) In East-street, on both sides, from a point 43 yards south-east of the commencement of the tramway for a distance of 52 yards, measured in a south-easterly direction.

(b) On both sides from a point 37 yards east of the easterly corner of Crown Point Axle Works for a distance of 27 yards, measured in

an easterly direction.

(c) In East-street on both sides, from a point 9 yards west of the intersection of the line, if extended, of the party wall of the Waterloo Inn and the centre line of East-street for a distance of 77 yards, measured in an easterly direction.

(d) In Cross Green-lane on the south side, from a point 30 yards east of the intersection of the centre lines of Ellerby-lane and Cross Green-lane for a distance of 41 yards, measured

(e) In Cross Green-lane on both sides, from a point 5 yards east of the intersection of the centre lines of Grand-street and Cross Greenlane for a distance of 50 yards, measured in an easterly direction.

(f) In Cross Green-lane on both sides, from a point 3 yards east of the intersection of the centre lines of South Accommodation-road and Cross Green-lane for a distance of 100 yards,

measured in an easterly direction.

Tramway No. 3-

In Otley-road-

(a) On the west side from a point 32 yards south of the intersection of the centre lines of Glen-road and Otley-road for a distance of 145 yards, measured in a northerly direction.

(b) On the west side from a point 17 yards south of the centre of the lodge at the filter beds of the Corporation for a distance of 273 yards, measured in a northerly direction.

(c) On both sides from the centre of the entrance gate to Weetwood Mount for a distance of 257 yards, measured in a northerly direction.

(d) On both sides from a point 9 yards north of the intersection of the centre lines of Old Otley-road and Otley-road for a distance of 739 yards, measured in a northerly direction.

2. The intended tramways are proposed to be constructed on a gauge of 4 feet 8½ inches, or such other gauge as may be determined, and it is not intended to run thereon carriages or

trucks adapted to run on railways.

3. The motive power to be used on the said tramways will be animal power, or any mechanical power (including in that expression steam, electric and any other motive power not being animal power), or partly one such power

and partly another.

The Order will vary or extinguish all rights and privileges inconsistent with, or which would or might in any way interfere with its objects, and will confer other rights and privileges, and will incorporate with itself with amendments all or some of the provisions of the Tramways Act, 1870, and the Lands Clauses Acts, and enable the Corporation (in addition to the powers herein specially mentioned) to exercise all or any of the powers by the Tramways Act, 1870, conferred on the persons therein referred to as the promoters.
