ADMINISTRATIVE COUNTY OF LONDON AND DISTRICT ELECTRIC POWER COMPANY.

(Incorporation of Company; Generation and Supply of Electricity; Agreements with London County Council with respect thereto; Subsidiary Agreements with other Authorities and Companies, Bodies and Persons; Exercise by Company by Agreement of certain Powers of London County Council; Leasing of Lands and Generating Stations; Execution of Works; Charges; Incorporation, Application and Amendment of Acts; other Purposes.)

NOTICE is hereby given, that application is intended to be made to Parliament in the ensuing Session for leave to bring in a Bill (hereinafter called "the Bill") for effecting all or some of the (amongst other) purposes hereinafter mentioned.

(In this Notice the "County Council" means the London County Council, the "area of supply" means the area within which the County Council may by the Notice or Notices as published in the London Gazette of any Bill or Bills promoted by the County Council in the ensuing or any succeeding Session or by any such Bill or by any Act obtained by the County Council in the ensuing or any succeeding Session seek to be or be

authorized to generate and supply electrical energy, the "Commons Committee" means the Select Committee of the House of Commons to whom the London County Council (Electric Supply) Bill, 1906, was referred, the "report of the Commons Committee" means the special report of the Commons Committee to the House of Commons.)

1. To incorporate a Company (hereinafter called "the Company") and to confer upon the Company all such powers as may be necessary to enable the Company and the County Council to enter into and carry into effect an agreement or agreements in pursuance of and for the purpose of giving effect to the recommendations (b) and (c) set forth in paragraph 18 of the report of the Commons Committee (that is to say) :—

"(b) The County Council may retain for itself one part of the undertaking while permitting a private enterprise to undertake another part."

"(c) The County Council may lease for a substantial consideration the whole enterprise to a private enterprise to resume possession of it when its initial stages are over."

2. To empower the Company under agreement with the County Council and under such subsidiary agreements with any other local authority, company, body or person or any government department as may be necessary or expedient, to enable the Company to carry into effect any agreement or agreements with the County Council to—

(1) Generate and supply electrical energy within or beyond the area of supply.

(2) Give to or take from any such local authority, company, body or person or any government department for use within or beyond the area of supply a supply of electrical energy or of plant or fittings, or to render services in connection therewith.

(3) Demand and recover the prices which under any such agreements or the Bill may be charged by the Company for such supply or services.

(4) Execute any works authorized and exercise all or any of the powers conferred by Parliament on the County Council or any such local authority, company, body or person or government department for the generation supply, transformation or use of electrical energy within or beyond the area of supply.

3. To empower the Company for the purposes of any such agreement with the County Council to construct, erect, lay down, maintain, work and use electrical generating stations and all other kinds of electrical works, and produce, generate, purchase, use, transmit, transform, distribute, supply and utilize electrical energy, and to manufacture gas for the purpose of generating energy thereby and generally to carry out the purposes of an electrical supply company and for other the purposes of the Bill, with powers to (by agreement or otherwise) acquire, manufacture, construct, erect, maintain, enlarge, alter, work and use or discontinue, hire, sell, let and dispose of all such lands, easements, buildings, collieries, wharves, vessels, barges, railways, tramways, undertakings, works, machinery, plant, stock, electric current wires, lamps, motors, fittings, meters and of all such apparatus, material, matters and things, and to obtain and exercise all such powers, and do all such works and supply such material and products, matters and things as may be necessary or convenient in, for or in connection with or as
