

EAST SUFFOLK (SWINE-FEVER) ORDER OF 1906 (No. 7).

The Board of Agriculture and Fisheries, by virtue and in exercise of the powers vested in them under the Diseases of Animals Acts, 1894 to 1903, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

Extension of application of East Suffolk (Swine-Fever) Order of 1906 (No. 5).

1. From and after the commencement of this

Order the provisions of the East Suffolk (Swine-Fever) Order of 1906 (No. 5), as modified by the East Suffolk (Swine-Fever) Order of 1906 (No. 6), shall apply to the Districts described in the Schedule to this Order.

2. This Order shall come into operation on the third day of December, nineteen hundred and six.

Districts of Local Authorities to which this Order Applies.

Those parts of the counties of East and West Suffolk which comprise the petty sessional divisions of Framlingham, Bosmere, and Claydon (including its detached part), Samford, and Cosford (except the parish of Thorpe Morieux), that part of the petty sessional division of Woodbridge which lies to the west of the River Deben, and the parishes of Stowmarket, Stowupland, Creeting St. Peter, Combs, Great Finborough, and Little Finborough.
