line commencing at the point in the middle of the line of the London and North Western Railway where the boundaries of the said new parish of Saint Matthew, Stockport, the said parish of Cheadle and the parish of Saint Thomas, Stockport, in the said county and diocese, all meet, and extending thence first southward, then south-westward and then westward along the middle of the Warrington and Stockport Line of the said London and North Western Railway for a distance of one mile or thereabouts to the point where the said Warrington and Stockport Line of railway is crossed by the boundary which divides the said parish of Cheadle from the said new parish of Saint Matthew, Stockport.

And whereas drafts of the said scheme or representation have been transmitted to the Patrons and to the Incumbents of the cures affected by the arrangements which are contemplated by such scheme or representation and such Patrons and Incumbents have respectively

signified their assent thereto.

And whereas the said scheme or representation has been approved at the Council held under the authority of the said Commission: now, therefore, His Royal Highness The Prince of Wales, being authorized in that behalf by writing under His Majesty's Sign Manual, doth hereby, by and with the advice of His Majesty's Privy Council, on behalf of His Majesty, ratify the said scheme or representation, and order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette, pursuant to the said Acts; and His Royal Highness The Prince of Wales doth further, on His Majesty's behalf, by and with the like advice, direct that this Order be forthwith registered by the Registrar of the said diocese of Chester.

HEREAS His Majesty was pleased, by His Commission dated the fifth day of March, one thousand nine hundred and seven, to nominate and appoint His Royal Highness The Prince of Wales, in His Majesty's absence from His Realm in Foreign Parts, to hold on His Majesty's behalf, His Privy Council, and to signify thereat His approval of any matter or thing whereunto His Royal Highness should be so authorized by writing under His Majesty's Sign Manual, and to do further on His Majesty's behalf any matter or thing for the purposes of the said Commission whereunto His Royal Highness should be authorized in manner aforesaid:

And whereas the Ecclesiastical Commissioners for England have, in pursuance of the Act of the fifty-ninth year of His late Majesty King George the Third, chapter one hundred and thirty-four; of the Act of the second and third years of Her late Majesty Queen Victoria, chapter forty-nine; of the Act of the fourteenth and fifteenth years of Her said late Majesty, chapter ninety-seven; and of the Act of the nineteenth

and twentieth years of Her said late Majesty, chapter fifty-five, duly prepared and laid before His Majesty in Council a representation, bearing date the twenty-eighth day of February, in the year one thousand nine hundred and seven, in the

words following, that is to say:—
"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the fifty-ninth year of His late Majesty King George the Third, chapter one hundred and thirty-four; of the Act of the second and third years of Her late Majesty Queen Victoria, chapter forty-nine; of the Act of the fourteenth and fifteenth years of Her said late Majesty, chapter ninety-seven; and of the Act of the nineteenth and twentieth years of Her said late Majesty, chapter fifty-five, have prepared and now humbly lay before Your Majesty in Council, the following representation as to the assignment of a district chapelry to the consecrated church of Saint Mark, situate at Washwood Heath, in the new parish (sometime district) of Saltley in the county of Warwick, and in the diocese of Birmingham.

"Whereas it appears to us to be expedient that a district chapelry should be assigned to the said church of Saint Mark, situate at Washwood

Heath as aforesaid.

"Now, therefore, with the consent of the Right Reverend Charles, Bishop of the said diocese of Birmingham (testified by his having signed and sealed this representation), we, the said Ecclesiastical Commissioners, humbly represent that it would, in our opinion, be expedient that all that part of the said new parish of Saltley which is described in the schedule hereunder written, all which part, together with the boundaries thereof, is delineated and set forth on the map or plan hereunto annexed, should be assigned as a district chapelry to the said church of Saint Mark, situate at Washwood Heath as aforesaid, and that the same should be named 'The District Chapelry of Saint Mark, Washwood Heath.

"And with the like consent of the said Charles, Bishop of the said diocese of Birmingham (testified as aforesaid), we, the said Ecclesiastical Commissioners, further represent that it appears to us to be expedient that banns of matrinony should be published, and that marriages, baptisms, churchings, and burials should be solemnized or performed at the said church of Saint Mark, situate at Washwood Heath as aforesaid, and that the fees to be received in respect of the publication of such banns and of the solemnization or performance of the said offices should be paid and belong to the minister of the same church for the time being: Provided always, that nothing herein contained shall be construed as expressing any intention on the part of us, the said Commissioners, to concur in or approve the taking of any fee for the performance of the said office of baptism or for the registration thereof.

"We, therefore, humbly pray that Your Majesty will be graciously pleased to take the premises into Your Royal consideration and to make such Order with respect thereto as to Your Majesty, in Your Royal wisdom, shall seem meet.

"The SCHEDULE to which the foregoing Representation has reference.

"The District Chapelry of Saint Mark, Washwood Heath, being:—

"All that part of the new parish (sometime district) of Saltley, in the county of Warwick, and in the diocese of Birmingham, which is bounded upon the east by the new parish of Saint Margaret, Ward End, upon the north by the new parish of Erdington, upon part of the
