The Board of Trade have received, through the Secretary of State for Foreign Affairs, a copy of a Despatch, dated March 28th, from His Majesty's Representative at Sofia, intimating that the Bulgarian Government have ordered the application of the following Quarantine measures :-

Ships from infected places to a destination in Bulgaria which carry merchandise from those places, and which during their voyage have discharged a part of their cargo in a port free from infection will be admitted to free pratique after a thorough medical inspection before the expiration of 25 days following the date of their departure from the infected places, provided that they are furnished with a clean bill of health.

The crews of these ships will be under surveillance during the whole of their stay in the Bulgarian ports of the Black Sea.

The despatch also states that the following places have been declared free from plague :-

(a) The Islands to the east of Australia-New Caledonia;

(b) The Australian towns of Adelaide and Sydney;

(c) Port Allégré, in Brazil.
