ORDER OF THE REGISTRAR-GENERAL IN ENGLAND.

(Dated 25th April, 1907.)

Whereas by the twenty-first section of the Births and Deaths Registration Act, 1874, it is enacted that the Registrar-General, with the sanction of the Local Government Board, may from time to time alter Registration Sub-Districts:—

1. And whereas it is expedient (1) that Stowey Sub-District of Bridgwater Registration District should be abolished and its constituent Civil Parishes transferred to other Sub-Districts of the same Registration District as follows:— (a) Cannington, Fiddington, Otterhampton and Stockland Bristol Civil Parishes to Bridgwater Sub-District; and (b) Aisholt, Charlinch, Nether Stowey, Over Stowey and Spaxton Civil Parishes to North Petherton Sub-District; (2) and that the small part of North Petherton Civil Parish now included in Middlezoy Sub-District of Bridgwater Registration District should be transferred to North Petherton Sub-District of the same Registration District in which the other and principal part of that Civil Parish is situated.

2. Now therefore I, Sir William Cospatrick Dunbar, Bart., C.B., Registrar-General of Births, Deaths, and Marriages in England, in exercise of the powers given me by the above mentioned Act, and with the sanction of the Local Government Board, do hereby order and declare that the foregoing alteration shall take effect accordingly.

3. This Order shall come into operation on the first day of May, nineteen hundred and seven.
