Declaration of Swine-Fever Infected Area.

1. The Area described in the Schedule to this Order is hereby declared to be an area infected with swine-fever for the purposes of the Swine-Fever (Infected Areas) Order of 1902.

ORDER OF THE BOARD OF AGRICULTURE AND FISHERIES.

The Board of Agriculture and Fisheries, by virtue and in exercise of the powers vested in them under the Diseases of Animals Acts, 1894 to 1903, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

1. Article 6 (2) of the Sheep-Dipping (England) Order of 1907, which restricts the movement of sheep until they have been dipped, shall not apply in the case of movement of sheep from any premises in the administrative county of Northampton or the county borough of Northampton for the purpose of exposure in a market, fair-ground or saleyard, if the movement of the sheep from those premises is authorised by a licence which may be granted by an Inspector of the Local Authority of the District in which those premises are situate.
