## Chancery of the Royal Victorian Order, St. James's Palace, May 31, 1907.

The KING has been graciously pleased to make the following appointments to the Royal Victorian Order, to take effect from the dates noted:—

To be Honorary Member of the Fifth Class:

4th May, 1907. Marius Hyacinthe Auguste Riffart, Chief of the Postal Service, Rue Boissy District, Paris.

To be Member of the Fourth Class:

25th May, 1907. Captain Anthony William Maunsell Atthill (late, Reserve of Officers), Chairman of the Royal Norfolk Veterans' Association.

The following Scheme for the adjustment of the property, rights, liabilities, &c., of the Urban District Council of Nuneaton and Chilvers Coton, in the county of Warwick, and for other purposes, as settled by a Committee of His Majesty's Most Honourable Privy Council, is published in accordance with the provisions of the Municipal Corporations, Act, 1882:--

Whereas by the Municipal Corporations Acts, 1882 and 1885, it is enacted that where a Petition for a Charter of Incorporation is referred to the Committee of His Majesty's Most Honourable Privy Council, and it is proposed by the Charter to extend the Municipal Corporations Acts to the municipal borough to be created by the Charter, the said Committee of the Council may settle a Scheme for the purposes in the said Acts named, and containing such provisions as are in the said Acts particularised :

And whereas in the month of July, one thousand nine hundred and five, certain inhabitant householders of the urban district of Nuneaton and Chilvers Coton, in the county of Warwick, petitioned His Majesty the King praying for a Grant of a Charter of Incorporation:

And whereas the said Petition for a Charter was referred to the Committee of Council, and it was proposed by the Charter to create the urban district of Nuneaton and Chilvers Coton, hereinafter described, a municipal borough, and to incorporate the inhabitants thereof, and to extend the Municipal Corporations Acts to the Municipal Borough to be created by the Charter:

And whereas under and by virtue of the Local Government Act, 1848, the Local Board for the parish of Nuneaton, and the Local Board for the parish of Chilvers Coton were both constituted in the year one thousand eight hundred and fifty, and then became invested with various powers and duties, and the Local Boards were constituted the Urban Sanitary Authorities for the parishes of Nuneaton and Chilvers Coton respectively:

And whereas by an Order of the County Council dated the eighteenth day of May, one thousand eight hundred and ninety-two, and confirmed on the thirtieth day of January, one thousand eight hundred and ninety-three, the Local Board of Nuneaton and the Local Board of Chilvers Coton were amalgamated and became the Nuneaton and Chilvers Coton Local Board (hereinafter called the "Local Board"), and by the same Order the district of Nuneaton and. Chilvers Coton was constituted and divided into

two wards, namely, the Nuneaton Ward and the Chilvers Coton Ward:

And whereas under and by virtue of the Local Government Act, 1894, the Local Board became the Urban District Council for the urban district of Nuneaton and Chilvers Coton (hereinafter called "the District Council"):

And whereas the District Council is now the Local Education Authority within the urban district of Nuneaton and Chilvers Coton (hereinafter called "the District") for the purposes of Part 3 of the Education Act, 1902, and a scheme for the constitution of an Education Committee was made by the District Council on the twentyfifth day of March, one thousand nine hundred and three, and was approved by the Board of Education on the thirtieth day of April, one thousand nine hundred and three:

And whereas there are two duly constituted Burial Boards in the district, viz.: (a) The Nuneaton Burial Board for the ecclesiastical district of Nuneaton, constituted under the provisions of the Burial Acts, 1852 to 1871, at a meeting of the Vestry for the said ecclesiastical district held on the sixth day of January, one thousand eight hundred and seventy-four; and (b) the Attleborough Burial Board for the ecclesiastical parish of Attleborough, constituted under the provisions of the Burial Act, 1855, at a meeting of the Vestry of the said ecclesiastical parish held on the twenty-fourth day of February, one thousand eight hundred and ninety-two:

And whereas the said Nuneaton Burial Board and the said Attleborough Burial Board are respectively the owners in fee simple of certain lands within the district, and which said lands are laid out and used for the purposes of burial grounds:

And whereas tables of fees duly allowed and approved in accordance with the provisions of the Burial Acts are now in force within the district:

And whereas in pursuance of the powers in that behalf contained in section 131 of the Public Health Act, 1875, the District Council has entered into an Agreement dated the seventh day of November, one thousand nine hundred and four, as amended by a Supplemental Agreement dated the sixth day of November, one thousand nine hundred and five, with the Nuneaton Rural District Council, the Foleshill Rural District Council, the Atherstone Rural District Council, and the Urban District Council of Bulkington for the provision and maintenance of a Hospital, for the treatment of cases of small pox arising in the district and in the districts of the above named authorities, on the terms and conditions set out in the above named Agreement.

And whereas the following Acts have been adopted by the Urban District Council, and are now in force in the district (that is to say):—

1. The Infectious Disease (Prevention) Act, 1890, adopted on the first day of September, one thousand eight hundred and ninety-four.

2. The Public Health Acts Amendment Act, 1890, adopted on the ninth day of February, one thousand eight hundred and ninety-one.

3. The Housing of the Working Classes Act, 1890 (Part 3), adopted on the twelfth day of July, one thousand nine hundred and one.

of July, one thousand nine hundred and one. 4. The Private Streets Works Act, 1892, adopted on the second day of March, one thousand eight hundred and ninety-six.

5. The Public Libraries Act, 1892, adopted on the twentieth day of November, one thousand eight hundred and ninety-five. 6. The Baths and Wash-houses Acts,
