ORDER OF THE BOARD OF
AGRICULTURE AND FISHERIES.

(DATED 6TH JUNE 1907.)

The Board of Agriculture and Fisheries, by virtue and in exercise of the powers vested in them under the Diseases of Animals Acts, 1894 to 1903, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

1. The Swine-Fever (Infected Areas) Order of 1902 shall not be deemed to prohibit the holding of the exhibition mentioned in the Schedule hereto.

2. Notwithstanding the provisions of any Order of the Board relating to swine-fever and made under the said Acts, swine may (subject as hereinafter provided) be moved to the exhibition mentioned in the Schedule hereto, and from such exhibition to any place of destination in Great Britain if accompanied by a Licence authorising such movement granted under this Order; Provided that this Article shall not extend to swine in a Swine-Fever Infected Place, or to swine of which the movement is prohibited by notice of an Inspector of the Local Authority or of the Board of Agriculture and Fisheries given under any Order of that Board; Provided also that in the case of a pig in a Swine-Fever Infected Area the licence authorising its movement to the exhibition shall be granted only on a Declaration signed by the owner of the pig or his agent authorised in writing for this purpose in the Form C set forth in the Schedule to the Swine-Fever (Infected Areas) Order of 1902, or to the like effect.

3. In the case of movement to the said exhibition the Licence shall be one granted by some person authorised in that behalf by the Lincoln City Council, and in the case of movement from the said exhibition the Licence shall be one granted by an Inspector of the Local Authority of the District in which the place of destination is situate.

DORSETSHIRE (SWINE-FEVER) ORDER
OF 1907 (No. 2).

The Board of Agriculture and Fisheries, by virtue and in exercise of the powers vested in them under the Diseases of Animals Acts, 1894 to 1903, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

Modification of Dorsetshire (Swine-Fever) Order of 1907.

1. Part II (*Restriction on Movement of Swine within Scheduled Area*) of the Dorsetshire (Swine-Fever) Order of 1907, hereinafter referred to as the "principal Order," is hereby modified in the manner hereinafter contained.

Declaration for Movement of Swine for Breeding Purposes.

2. In the case of swine moved for breeding purposes from any premises in the Scheduled Area to which the principal Order applies (except premises situate in the petty sessional divisions and other places mentioned in the Schedule hereto), a period of fourteen days may be inserted in the declaration required by the principal Order instead of twenty-eight days.

Commencement.

3. This Order shall come into operation on the tenth day of June, nineteen hundred and seven.

Short Title and Construction.

4. This Order may be cited as the DORSETSHIRE (SWINE-FEVER) ORDER OF 1907 (No. 2), and shall be read as one with the principal Order.
