The covenants and conditions contained in such lease on the part of the lessees are as follows :—

2. To provide on the said tramways an efficient service of cars in connection with and as part of the Salford tramway system at intervals of not more than 15 minutes between the hours of 8 A.M. and 10 P.M.

3. Not to use the said tramways for the conveyance of objectionable matter nor for goods traffic to a greater extent than on the Bury Newroad Tramways of the lessees.

4. To observe all present and future enactments,

bye-laws and regulations which ought to be observed and performed in relation to the exercise upon the said tramways of any rights thereby demised.

5. To publish inside each carriage running on the said tramways the tolls and charges appointed to be taken, not exceeding the tolls and charges authorised by the Council's Provisional Order.
