and also so much of the road as lies between the rails of the tramways and the portion of the road between the two lines of tramways and also 18 inches on either side of the tramways, and generally to do all repairs necessary for keeping the said tramways in good working order, but this should not compel the lessees to cleanse or water the said tramways or the roads or any parts thereof.

8. To render statements of receipts and expenditure, &c., with power for the lessors to nominate any person to examine books and

check such statements.

The covenants and conditions mutually agreed between the lessors and the lessees are as

follows:

9. The lessees to permit the Manchester Corporation to have running powers over Tramway No. 2 from its termination at the boundary between the Prestwich district and the borough of Salford to Heaton Park Station.

- 10. The lessees to be entitled (except as therein mentioned) to the exclusive use of the tramways, and to be subject to rights and obligations of the lessors under the Prestwich Urban District Council Tramway Order, 1900. The lessors to be entitled to the use of the said tramways for conveying road material and refuse between the hours of 12 midnight and 5 A.M., but not so as to interfere with the use of the said tramways by the lessees.
- 11. Reservation to the lessors of their powers as a local or road authority to open and break up the roadway, &c.

12. Power of re-entry if the working of the said tramways is discontinued for three months.

- 13. Power of re-entry and distress for rent in arrear.
 - 14. Lessees to be liable for acts of servants.
 - 15. Disputes to be referred to arbitration.

The covenants and conditions on the part of the lessors are as follows:

16. For quiet enjoyment.

17. Not to seek powers to construct competing tramways.

18. Giving the lessees option of lease of

additional non-competing tramways.

19. Except as therein provided not to use or seek power to use the demised tramways or additional tramways, or to assist any person, company, or corporation to obtain running powers over any such tramways, and not to assist any person, company, or corporation (other than the lessees) to obtain statutory power to construct tranways in their district in the roads in which the demised tramways are situate.

The following provisions to have effect with regard to the electrical equipment:—

20. Lessees to provide and maintain electrical equipment.

21. Lessors to have option to purchase

electrical equipment.

22. If option to purchase not exercised by lessors, lessees may remove electrical equipment, making good all damage caused by such removal.

23. Additional crossings, passing places, sidings, junctions, or other works, if desired by the lessees and necessary or convenient, to be constructed by the lessors, the lessees paying an additional rent in respect thereof.

24. Proviso that in default of the lessors carrying out such works, the same may be carried out by the lessees, but in such case they should pay no rent in respect thereof, and should restore any street or streets broken up as soon as possible.

The draft lease is deposited at the office of the lessors, situate at Chester Bank, Prestwich, and may be inspected at any time during office hours.
