## ORDER OF THE BOARD OF AGRICULTURE AND FISHERIES.

(DATED 2ND JULY 1907.)

The Board of Agriculture and Fisheries, by virtue and in exercise of the powers vested in them under the Diseases of Animals Acts, 1894 to 1903, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

Article 11 of the Swine-Fever (Regulation of Movement) Order of 1903 (Provision for Movement through Scheduled Area) shall in its application to the Area described in the First Schedule hereto be extended so as to apply to swine moved from the county of Dorset by road to any railway station mentioned in the Second Schedule hereto for movement to a place outside such Area if accompanied by a licence authorising their movement to such place granted by the Local Authority of the District in which such place is situate, or by an Inspector of such Local Authority, under
