to be submitted to His Majesty the King in Council to be dealt with as provided in the said Act:-

#### STATUTE.

1. In the Statutes made by the Commissioners for Queen's College, Stat. Tit. II, Clause I, at the end of the section the following words shall be struck out:-

"Of these not more than nine shall be Official Fellowships, so long as the total number of Fellowships shall not exceed fourteen, and not more than ten so long as the total number shall not exceed sixteen. The remainder shall be ordinary Fellowships.

2. In the Statutes made by the Commissioners for Queen's College, Stat. Tit. II, Clause 2, at the end the words "Provided further" to "on those terms" shall be struck out.

3. In the Statutes made by the Commissioners for Queen's College, Stat. Tit. II, Clause 7, at the end the words "Provided that the aggregate" to "by these Statutes" shall be struck out.

4. In the Statutes made by the Commissioners for Queen's College, Stat. Tit. II, Clause 8, at the end of the last paragraph but one of the section the following words shall be struck;

"And shall not exceed two in number."

5. In the Statutes made by the Commissiouers for Queen's College, Stat. Tit. II, Clause 9, after the words "Unless at the time of giving notice of election to" the words "an Ordinary shall be struck out and the word "a" shall be substituted for them.

6. In the Statutes made by the Commissioners for Queen's College, Stat. Tit. II, Clause 15, after the words "upon his appointment" the words "if there be then" to "the office of

Tutor" shall be struck out.

7. In the Statutes made by the Commissioners for Queen's College, Stat. Tit. XXIII, Clause 8, after the words "respecting the number of" the words "Official Fellowships and that of Fellowships in general" shall be struck out, and the word "Fellowships" shall be substituted for them; in the same clause at the end the words: from "and a Fellowship" to "reckoned as an' Official Fellowship" shall be struck out.
