

the Acts 40 Vic., cap. 2, and 52 Vic., cap. 6, to the amount of £2,500,000, being £1,000,000 in replacement of Bills falling due on the 28th instant, and £1,500,000 in replacement of the balance of those temporarily paid off on 12th April, 1907.

2. The Bills will be in amounts of £1,000, £5,000, or £10,000. They will be dated the 27th July, 1907, and will be payable at six months after date, viz.:—on the 27th January, 1908.

3. *The Tenders must specify the net amount per cent. which will be given for the amounts applied for, and the Tenders of private individuals must be made through a London Banker.*

4. The Bills will be issued and paid at the Bank of England.

5. The persons whose Tenders are accepted will be informed of the same on Tuesday, the 23rd instant, and payment in full of the amounts of the accepted Tenders must be made to the Bank of England not later than twelve o'clock, on Saturday, the 27th July, 1907.

6. The Lords Commissioners of His Majesty's Treasury reserve the right of rejecting any Tenders.

LIGHT RAILWAYS ACT, 1896.

East and West Yorkshire Union Light Railway (Borrowing Powers) Order, 1907.

The Light Railway Commissioners have submitted to the Board of Trade for confirmation, under the above-mentioned Act, an Order made by them authorising the East and West Yorkshire Union Railways Company to exercise further borrowing powers.

Any objections to the confirmation of the Order should be addressed to the Assistant Secretary (Railway Department), Board of Trade, Whitehall Gardens, London, S.W., and must be lodged with the Board on or before the 9th August, 1907. ORDER of the Local Government Board: District Auditors Act, 1879: Assignment of Duties and District (Supplemental):—

NORTH-EASTERN COUNTIES AUDIT DISTRICT.

To Henry Ward Oliver, Barrister-at-Law, District Auditor;—

To the Yorkshire Inebriates Act Joint Committee;—

And to all others whom it may concern.

Whereas by section 4 of the District Auditors Act, 1879, it is enacted that the Local Government Board may from time to time assign to District Auditors their Duties, and the Districts in which such Auditors respectively are to act, and may from time to time change wholly or in part such Duties or Districts;

And whereas by an Order dated the 13th day of July, 1906, We, the Local Government Board, certified the appointment of Henry Ward Oliver as a District Auditor, and assigned to him the duties therein mentioned and the District in which he should act as Auditor, and which in the said Order was termed "The North Eastern Counties Audit District";

And whereas the Councils of the North, East, and West Ridings of Yorkshire, of the cities of Bradford and of Leeds, of the cities and counties of Kingston-upon-Hull and of York, and of the borough of Halifax have joined in appointing out of their respective bodies a Joint Committee for the purposes of the Inebriates Acts, 1879 to 1900;

And whereas the Joint Committee so appointed is known as the Yorkshire Inebriates Act Joint Committee and is an Authority whose Accounts are subject to be audited by a District Auditor, and it is desirable that the duty of auditing the Accounts of the said Joint Committee and of their Officers be assigned to the said Henry Ward Oliver;

Now therefore, in pursuance of the powers given to Us by the Statutes in that behalf, We hereby Order and Prescribe that it shall, until We otherwise Prescribe, be the duty of the said Henry Ward Oliver to audit the Accounts of the said Joint Committee, and of their Officers, in conformity with the provisions contained in Article II of the above-cited Order; and that for the purpose of such Audit the area within which the powers, authorities, and jurisdiction of the Joint Committee may be exercised shall be deemed to be within the said North-Eastern Counties Audit District.
