The KING has been pleased to appoint Colonel Sir William Henry Manning, K.C.M.G., C.B. (late Inspector-General of the King's African Rifles), to administer the Government of the Nyasaland Protectorate in the absence of the Governor.

Whitehall, June 29, 1907.

The KING has been graciously pleased to grant unto Edmund Williams Tom Llewelyn Brewer, of Dan-y-graig, in the parish of Christchurch, and of Maesruddud, in the parish of Bedwelty, both in the county of Monmouth, Esquire, Master of Arts of the University of Oxford, Barrister-at-Law of the Inner Temple, in the Commission of the Peace and a Deputy-Lieutenant for the said county of Monmouth, His Royal licence and authority that he may take and use the surname of Williams in addition to and after his own surname of Brewer, that he may bear the arms of Williams and Brewer quarterly, and that such surname and arms may, in like manner, be taken, borne, and used by his issue, such arms being first duly exemplified according to the laws of arms and recorded in the College of Arms, otherwise the said Royal licence and permission to be void and of none effect.

And also to command that the said Royal concession and declaration to be recorded in His Majesty's said College of Arms.
