# MOTOR CAR ACT, 1903. County of Kesteven.

W HEREAS by sub-section 1 of section 9 of the Motor Car Act, 1903, it is enacted that within any limits or place referred to in regulations made by the Local Government Board, with a view to the safety of the public, on the application of the local authority of the area in which the limits or place are situate, a person shall not drive a motor car at a speed exceeding ten miles per hour:

Notice is hereby given, that the County Council of Kesteven have made application to the Local Government Board for a regulation to be made in pursuance of the said sub-section, putting the above provisions of that sub-section in force within the limits comprising the following portion of a road in the parish of Colsterworth, that is to say:—So much of the Great North Road (including High-street, Colsterworth) as extends from a point in the said road situate 8 furlongs and 30 yards north of its junction with New-road to a point in the said Great North Road situate 1 furlong and 59 yards south of its junction with that road.

Notice is hereby further given, that objections to the making of any such regulation may be sent in writing to the Local Government Board at their offices at Whitehall, London, on or before the sixth day of November, 1907.

A copy of any such objection should be sent at the same time by the objector to the County Council, addressed to the Clerk to the County Council of Kesteven, Sleaford.
