NOTICE is hereby given, that application under Rule 977 of the Statutory Rules and Orders, 1904, is intended to be made in the present month of October to the Light Railway Commissioners by the Llandudno and District Electric Tramway Construction Company Limited, to include in the draft Order under the Light Railways Act, 1896; for which application was made to the Light Railway Commissioners in May 1907, provisions to authorize the Company (1.)
