ORDER OF THE BOARD OF AGRICULTURE AND FISHERIES.

(DATED 8TH NOVEMBER 1907.)

The Board of Agriculture and Fisheries, by virtue and in exercise of the powers vested in them under the Diseases of Animals Acts, 1894 to 1903, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

- 1. Notwithstanding the provisions of the Swine-Fever (Regulation of Movement) Order of 19.3, or of any Order by which such provisions are applied to any scheduled area, swine may be moved to the exhibition mentioned in the Schedule hereto, and from such exhibition to any place of destination in Great Britain situate in any scheduled area, if accompanied by a Licence authorising such movement.
- 2. In the case of movement to the said exhibition the Licence shall be one granted by some person authorised in that behalf by the Norwich City Council, and in the case of movement from the said exhibition the Licence shall be one granted by an Inspector of the Local Authority of the District in which the place of destination is situate.
- 3. The swine shall be moved by the nearest available route and without unnecessary delay to the exhibition or place of destination specified in the Licence and not elsewhere, and while being so moved shall not be subject to Regulations made by a Local Authority under any Order of the Board relating to Swine-Fever.

No. 1573.—BLACK SEA—KRIMEA.

Sevastopol Harbour Approach—Whistle Buoy temporarily replaced by Spar Buoy, Arc of Visibility of Light.

The Russian Government has given notice, dated 8rd October, 1907, that the whistle buoy in the

approach to Sevastopol Harbour has been temporarily replaced during repairs by a red spar buoy with a conical topmark.

Approximate position, lat. 44° $37\frac{3}{4}$ ′ N., long. 33° $28\frac{1}{4}$ ′ E.

Also, that St. Vladimir Light (alternating red and white), west of Quarantine Bay at the entrance to the Harbour, is now, in consequence of an alteration in the illuminant, visible outside the limits of the arc of visibility formerly given, viz., from S. 13° W., through south, to S. 73° E. Vessels approaching the harbour should not alter course towards the light until the red phases of the light are quite distinct.

Approximate position, lat. 44° 37′ N., long. 33° 29′ E.

Saco Bay—Shoal in Approach.
Cape Elizabeth Light-Vessel—Amended Position of.

According to a United States Government chart recently received, a shoal named Three Tree Ledge, with a depth of $4\frac{1}{3}$ fathoms over it, exists in the approach to Saco Bay, situated in a position from which the northern extremity of Stratten Island bears N. 61° W., distant $1\frac{e}{10}$ miles, and Wood Island Lighthouse S. 59° W.

Approximate position, lat. 43° 30′ N., long. 70° $16\frac{1}{4}$ ′ W.

As defined by the 5-fathom contour line, this shoal extends for a distance of 2 cables in a S. 47° W. direction from the above position.

Also, Cape Elizabeth Light-vessel is shown to be moored in approximately lat. 43° $31\frac{1}{2}'$ N., long. 70° $5\frac{3}{4}'$ W., or about 7 cables N. 32° W. from the position shown on the charts.
