ORDER OF THE BOARD OF AGRICULTURE AND FISHERIES.

(DATED 20TH NOVEMBER 1907.)

The Board of Agriculture and Fisheries, by virtue and in exercise of the powers vested in them under the Diseases of Animals Acts, 1894 to 1903, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows :

Movement of Swine to and from Brockenhurst Exhibition.

1. Article 2 of the New Forest (Swine-Fever) Order of 1907 so far as it requires a declaration for the purpose of obtaining a licence for movement into the perambulation of the New Forest shall not apply to the movement of swine to the exhibition mentioned in the Schedule hereto.

Movement of Swine from the Exhibition.

2.—(1.) Swine exposed at the said exhibition shall not be moved therefrom unless accompanied by a Licence authorising such movement or elsewhere than to a bacon-factory or slaughter-house specified in the Licence.
