make such Order in respect thereto as to Your Majesty in Your Royal wisdom shall seem meet.

"The SCHEDULE to which the foregoing Representation has reference.

"The Consolidated Chapelry of Saint Alban, Hindhead, comprising:—

"1. All that portion of the new parish (sometime district) of Saint John, Churt, in the county of Surrey, and in the diocese of Winchester, which is bounded upon the south-west and upon the south by the consolidated chapelry of Saint Luke, Grayshott, partly in the county of Southampton, and partly in the said county of Surrey, but wholly in the said diocese of Winchester, upon the east partly by the parish of Thursley and partly by the parish of Elstead, both in the said county of Surrey, and in the the said diocese of Winchester, upon part of the north by the last-named parish, and upon the remaining sides, that is to say, upon the remaining part of the north and upon the north-west, by an imaginary line commencing at the point east of Hyde Farmhouse where the boundary which divides the said parish of Elstead from the said new parish of Saint John, Churt, diverges Farm past Hyde Farm and Marchant Farm to Stock Farm, and extending thence generally westward along the middle of the said road for a distance of fifty-eight chains or thereabouts to its junction at Stock Farm with the road leading from Tilford to Hindhead, and extending thence southward along the middle of such road for a distance of fourteen chains or thereabouts to its junction with the road leading to Green Cross, and extending thence south-westward in a straight line for a distance of one mile or thereabouts to the point where the northern end of the wall or fence forming the western boundary of the house and premises known as Beacon Hill Park meets the southern side of the road leading from Churt to Hindhead, and continuing thence south-westward in precisely the same direction and in a straight line for a distance of thirty chains or thereabouts to a point in the middle of the stream which flows through Whitmoor Bottom, upon the boundary which divides the said new parish of Saint John, Churt, from the said consolidated chapelry of Saint Luke, Grayshott, and also the said county of Surrey, from the said county of Southampton.

"2. And also all that portion of the said consolidated chapelry of Saint Luke, Grayshott, which is bounded upon the north and upon the north-east by the above described portion of the said new parish of Saint John, Churt, and upon the remaining sides, that is to say, upon the south-east and upon the south-west, by an imaginary line commencing upon the boundary which divides the said new parish of Saint John, Churt, from the said consolidated chapelry of Saint Luke, Grayshott, at a point opposite to the Royal Huts Hotel at the junction of the road leading from Tilford to Hindhead with the high road leading from London to Portsmouth, and extending thence south-westward along the middle of the said high road for a distance of seventy-five yards precisely, and extending thence north-westward in a line parallel with and at a distance of seventy-five yards precisely from the middle of the said road leading from Hindhead to Tilford for a distance of twentysix chains, or thereabouts, to the boundary which divides the said consolidated chapelry of Saint Luke, Grayshott, from the said new parish of Saint John, Churt.

"3. And also all that other portion of the said consolidated chapelry of Saint Luke, Grayshott, which is bounded upon the south by the new parish of Saint Stephen, Shottermill, upon the east by the parish of Haslemere, both in the said county of Surrey, and in the said diocese of Winchester, and upon the north by the above described portion of the said new parish of Saint John, Churt, and upon the remaining side, that is to say, upon the south-west by an imaginary line commencing upon the boundary which divides the said new parish of Saint John, Churt, from the said consolidated chapelry of Saint Luke, Grayshott, at a point opposite to the Royal Huts Hotel, at the junction of the high road leading from London to Portsmouth, with the road leading from Hindhead to Haslemere, and extending thence first south-eastward and then southward along the middle of the last-mentioned road for a distance of twenty chains or thereabouts to the boundary which divides the said consolidated chapelry of Saint Luke, Grayshott, from the said new parish of Saint Stephen, Shottermill."

And whereas the said representation has been approved by His Majesty in Council: now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Winchester.

The KING's Most Excellent Majesty in Council. THEREAS by the Burial Act, 1858, as amended by the Burial Act, 1900, it was enacted that, in case it appeared to His Majesty in Council, upon the representation of the Local Government Board, that, for the protection of the public health, the opening of any new burial-ground in any city or town, or within any other limits, save with the previous approval of the Local Government Board, should be prohibited, or that burials in any city or town, or within any other limits, or in any burial-grounds or places of burial, should be wholly discontinued, or should be discontinued subject to any exception or qualification, it should be lawful for His Majesty, by and with the advice of His Privy Council, to order that no new burial-ground should be opened in any city or town, or within such limits, without such previous approval, or (as the case might require) that, after a time mentioned in the Order, burials in such city or town, or within such limits, or in such burial-grounds or places of burial, should be discontinued wholly, or subject to any exceptions or qualifications mentioned in such Order, and so from time to time as circumstances might require; provided always that notice of such representation, and of the time when it should please His Majesty to order that the same be taken into consideration by the
