"And whereas the transfer of the patronage of the said benefice of Baydon, which is hereinbefore mentioned and hereinafter recommended and proposed will in our opinion tend to make better provision for the cure of souls in the parish or district in or in respect of which the right of patronage or advowson so recommended and proposed to be transferred as aforesaid arises or exists, that is to say, in the parish or chapelry of Baydon.

Baydon. "Now therefore with the consent of the said William Lehman Ashmead Bartlett Burdett-Coutts (in testimony whereof he has signed and sealed this scheme) and with the consent of the said John, Bishop of Salisbury (in testimony whereof he has signed this scheme and sealed the same with his episcopal seal), we, the said Ecclesiastical Commissioners for England, humbly recommend and propose that upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this scheme and without any conveyance or assurance in the law other than such duly gazetted Order the whole advowson or perpetual right of patronage of and presentation to the said benefice of Baydon now vested in him the said William Lehman Ashmead Bartlett Burdett-Coutts as aforesaid, shall be transferred to the said John, Bishop of Salisbury, and his successors in the same bishoprick, and shall thereupon and thenceforth become and be absolutely vested in and shall and may from time to time be exercised by the said John, Bishop of Salisbury, and by his successors in the same bishoprick for ever.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any further or other measures relating to the matters aforesaid or any of them in accordance with the provisions of the said Acts or of any of them or of any other Act of Parliament."

And whereas the said scheme has been approved by His Majesty in Council: now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Salisbury.

W HEREAS the Ecclesiastical Commissioners for England have in pursuance of the Act of the third and fourth years of Her late Majesty Queen Victoria, chapter one hundred and thirteen, and of the Act of the seventeenth and eighteenth years of Her said late Majesty, chapter eighty-four, duly prepared and laid before His Majesty in Council a scheme, bearing date the fifth day of December, in the year one thousand nine hundred and seven, in the words following, that is to say :—

"We, the Ecclesiastical Commissioners for

England, in pursuance of the Act of the third and fourth years of Her late Majesty Queen Victoria, chapter one hundred and thirteen, and of the Act of the seventeenth and eighteenth years of Her said late Majesty, chapter eightyfour, have prepared and now humbly lay before Your Majesty in Council the following scheme for apportioning the income of the benefice (being a rectory) of Algarkirk, in the county of Lincoln, and in the diocese of Lincoln, between that benefice (being a vicarage) of Saint Paul, West Marsh, Great Grimsby, which said lastly named benefice is situate in the said county of Lincoln and in the said diocese of Lincoln.

"Whereas the Bishop of the said diocese of Lincoln is the Patron in right of his See of the said benefice of Algarkirk, and of the said benefice of Saint Paul, West Marsh, Great Grimsby.

"And whereas it has been made to appear to us that the said benefice of Saint Paul, West Marsh, Great Grimsby, is at present insufficiently endowed, and that the said benefice of Algarkirk has endowments of such an amount as that after the apportionment hereinafter recommended and proposed to be made shall have been made, the said benefice of Algarkirk will still be sufficiently endowed.

"And whereas we, the said Ecclesiastical Commissioners, are of opinion that additional provision should be made for the cure of souls within the new parish of Saint Paul, West Marsh, Great Grimsby, by means of that apportionment of the income of the said benefice of Algarkirk which is hereinafter recommended and proposed.

"And whereas the said benefice of Algarkirk is now full.

"Now, therefore, with the consent of the Right Honourable and Most Reverend Randall Thomas, Archbishop of Canterbury, acting as Archbishop of the province within which each of the said two benefices is situate (in testimony of which consent he has signed this scheme, and sealed the same with his archiepiscopal seal), and with the consent of the Right Reverend Edward, Bishop of the said diocese of Lincoln, acting as such Bishop and also as the Patron in right of his See of each of the said two benefices as aforesaid (in testimony of which consent he has signed this scheme and sealed the same with his episcopal seal), we, the said Ecclesiastical Commissioners, humbly recommend and propose that without any conveyance or assurance in the law other than this scheme, and any duly Gazetted Order of Your Majesty in Council ratifying the same, and as from the day on which, from whatsoever cause, the said benefice of Algarkirk shall next be avoided the following apportionment of the income of the same benefice shall take place, that is to say, all the glebe lands which may then belong, or which thereafter may belong to the said benefice of Algarkirk, shall be charged and for ever thereafter chargeable in favour of the Vicar or Incumbent for the time being of the said benefice of Saint Paul, West Marsh, Great Grimsby, with one clear annual sum or yearly rent charge of one hundred and twenty pounds, such clear annual sum or yearly rent charge to be due and payable to the Vicar or Incumbent of the said benefice of Saint Paul, West Marsh, Great Grimsby, and to be apportionable between any outgoing Vicar or Incumbent of the said benefice of Saint Paul, West Marsh, Great Grimsby, or his representatives on the one hand, and his successor in the same incumbency on the other hand, and to be receivable by the Vicar or Incumbent in whose favour it is
