ORDER OF THE REGISTRAR-GENERAL  
IN ENGLAND.

(Dated January 21st, 1908).

WHEREAS by the 21st Section of the Births and Deaths Registration Act 1874, it is enacted that the Registrar-General, with the sanction of the Local Government Board, may from time to time alter Registration Sub-districts.

1. And whereas it is expedient with a view to make the several Registration Districts herein

mentioned co-extensive with the Poor Law Unions of the same names as altered by Local Government Board Provisional Order No. P. 2061 entitled "The Counties of Buckingham and Hertford (alteration of county boundaries) Order, 1906," which was confirmed by the Local Government Board's Provisional Orders Confirmation (No. 8.) Act, 1906, that the following areas coloured as stated on the maps sealed with the seal of the Local Government Board should be transferred as set forth hereunder, viz. :—
