"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid or any of them in accordance with the provisions of the said Acts or of any other Act of Parliament."

"The SCHEDULE to which the foregoing scheme has reference :---

"FIRST PART.

"All that piece or parcel of land situate at North Hyde, in the parish of Heston, in the county of Middlesex, containing twenty-five acres or thereabouts, bounded on the north side by the private canal there, which said land is delineated and coloured pink on the plan drawn on the said indenture of the thirteenth day of December, one thousand eight hundred and ninety-nine, together with the free and uninterrupted right in common with others entitled thereto to use free from obstruction the whole of the said private canal, the position of which is indicated on the said plan, and also in manner aforesaid to use the canal intended to be made to lead from Heston Farm into the said private canal if and when the same shall be made, and also the free right of passing and repassing with horses, carts, waggons and other vehicles, or on foot for all purposes upon, through and over the road marked on the said plan extending from the public road leading from Heston at the point marked A on the said plan to the public road leading to Cranford at the point marked B on the said plan, and through or over the towing paths by the side of the said private canal and proposed canal and through and over the road intended to be made from ficston Farm into the high road to Heston aforesaid, and also all such estate and interest or respective estates and interests as the said several persons parties to the aforesaid indenture of the thirteenth day of December, one thousand eight hundred and ninety-nine, of the first, second, third and fourth parts respectively are possessed of or entitled to, of and in all that piece or parcel of land covered with water forming part of the said private canal and delineated and coloured blue on the said plan.

## "Second Part.

The KING's Most Excellent Majesty in Council.

W HEREAS the Ecclesiastical Commissioners for England have in pursuance of an Act of the sixth and seventh years of Her late Majesty Queen Victoria, chapter thirty-seven, sections six and eight, duly prepared and laid before His Majesty in Council a scheme bearing date the ninth day of April, in the year one thousand nine hundred and eight, in the words and figures following, that is to say :--

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the sixth and seventh years of Her late Majesty Queen Victoria, chapter thirty-seven, have prepared and now humbly lay before Your Majesty in Council the following scheme for authorizing the sale and disposal of certain property in the parish of Godmanchester, in the county of Huntingdon, now vested in us.

"Whereas under and by virtue of the several indentures, particulars whereof are set forth in the schedule hereunder written, the lands and hereditaments situate in the parish of Godmanchester aforesaid, and particularly described in the same indentures and schedule became with their appurtenances and are now vested in us.

"And whereas none of the said lands and hereditaments are subject to any outstanding beneficial lease or grant but are now in our possession, but some portions thereof on account of their character or situation are unsuitable or inconvenient to be held or applied for the purposes for which estates vested in us are applicable under the Acts by which our proceedings are governed.

ings are governed. -"And whereas with a view to the advantageous appropriation of the same or of the proceeds thereof for the ultimate improvement of our common fund it is expedient that the said lands and hereditaments or such part or parts thereof as we shall at any time and from time to time think fit should be sold or disposed of and accordingly that we should be empowered to sell or dispose of our interest in such lands and hereditaments or in any part or parts thereof in such manner as shall appear to us advisable.

"Now therefore we humbly recommend and propose that we may be authorized and empowered by instrument or instruments in writing, duly executed according to law, from time to time to sell or dispose of and duly to convey, according to the provisions of the said Act, all or any of the said lands and hereditaments so vested in us as aforesaid, under and by virtue of the said several indentures or any of them with their appurtenances and all our estate, right, title, and interest therein or in any part or parts thereof unto and to the use of any person or persons desirous or willing to purchase the same and his or their heirs executors administrators or assigns or otherwise as he or they shall direct or appoint and for such consideration as shall upon due calculation and inquiry appear to us to be just and reasonable, it being our intention to invest the proceeds of such sale from time to time as occasion may arise in the purchase of other lands, tithes, rent-charges, tenements, or heredita-
