Helen and Saint Swithin, thence westward along the centre of Bull Entry following that boundary till it meets the present boundary between the parishes of Saint Andrew and Saint Helen, thence southward, eastward, and southward along that boundary to the centre of Copenhagen-street, thence eastward along the centre of Copenhagen-street till it meets the point first And all that part of the parish of Saint Alban lying to the northward of a line commencing in the centre of the River Severn opposite the west end of Warmstry Slip and continuing along the centre of Warmstry Slip till it reaches Little Fish-street, thence northward till it meets the present boundary between the parishes of Saint Alban and Saint Andrew, thence westward along that boundary to the centre of the River Severn and thence southward along the present boundary between the parishes of Saint John and Saint Alban till it meets the point first mentioned.

"The place or district or portion of land described in the second part of this schedule is more particularly specified as follows, namely, all that part of the parish of Saint Helen lying to the northward of a line commencing at a point in the centre of Pump-street opposite the Shambles and going eastward along the centre of Pump-street till it meets the present boundary between the parishes of Saint Helen and Saint Martin at the junction of Friar-street and Newstreet, thence following this boundary northward along the centre of New-street and westward till it meets the present boundary between the parishes of Saint Helen and Saint Swithin, thence along this boundary westward to the centre of the Shambles, thence southward along the centre of the Shambles till it meets the point first mentioned.

"The place or district or portion of land described in the third part of this schedule is more particularly specified as follows, namely, all that part of the parish of Saint Michael lying to the northward of a line commencing in the centre of the River Severn and passing eastward and afterwards northward along the present boundary between the parishes of Saint Michael and Saint Peter the Great till it meets the present boundary between the parish of Saint Michael and the precincts of the cathedral, thence along this last mentioned boundary southwestward until it reaches a point where this boundary turns northward, from thence due westward to the centre of the River Severn, thence along the present boundary between the parish of Saint Michael in Bedwardine and the parish of Saint John in Bedwardine south to the point first mentioned.
