

and eleven, section five, do hereby, subject as hereinafter mentioned, grant to the Incumbent for the time being of the vicarage of Saint Saviour, South Hampstead, in the county of Middlesex and in the diocese of London, one yearly sum or stipend of sixty pounds, such yearly sum or stipend to be payable out of the common fund under our control, and to be calculated as from the first day of May, in the year one thousand nine hundred and eight, and to be receivable in four equal portions on the first day of February, the first day of May, the first day of August, and the first day of November in each and every year: Provided always, that the annual sum or stipend so granted by us to the Incumbent of the said vicarage of Saint Saviour, South Hampstead, shall be paid only upon the production to us, on or after each of the said lastly-mentioned days in each and every year, of a certificate, under the hand of the Bishop of the said diocese of London that an Assistant-Curate, duly licensed by such Bishop, has been employed within the parish of Saint Saviour, South Hampstead aforesaid, during the quarter of the year then ended: Provided also, that such yearly sum or stipend shall continue payable as aforesaid so long only as may to us appear to be expedient under the circumstances from time to time affecting the said vicarage and parish of Saint Saviour, South Hampstead.

WE, the Ecclesiastical Commissioners for England, in consideration of a benefaction of a capital sum of two hundred pounds sterling which has been paid to us in favour of the vicarage of Holy Trinity, Walton Breck, in the county of Lancaster, and in the diocese of Liverpool, do hereby, in pursuance of the Act of the twenty-ninth and thirtieth years of Her late Majesty Queen Victoria, chapter one hundred and eleven, section five, grant out of our common fund to the said vicarage of Holy Trinity, Walton Breck, to meet such benefaction, one other capital sum of two hundred pounds, in respect of which so long as the same capital sum or any part thereof shall remain in our hands, there shall be paid by us to the Incumbent for the time being of the said vicarage one yearly sum of six pounds, or such part thereof as shall be proportionate to any balance of the same capital sum which shall so remain in our hands; the above-mentioned yearly payments to commence as from the twenty-eighth day of April, in the year one thousand nine hundred and eight, and to be receivable in equal quarterly portions on the first day of February, the first day of May, the first day of August, and on the first day of November in each and every year.
